

AGREEMENT FOR SERVICES #4244  
AMENDMENT 1

This Amendment 1 to that Agreement for Services #4244, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and The Center for Common Concerns, Inc., doing business as HomeBase, a non-profit organization, duly qualified to conduct business in the State of California, whose principal place of business is 870 Market Street, Suite 1228, San Francisco, CA 94102-2926, (hereinafter referred to as "Subrecipient");

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to produce and implement a Regional Strategic Plan for addressing Homelessness informed by national best-and-emerging practices; and in accordance with Agreement for Services #4244, dated October 22, 2019 incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to amend Article II, "Term;" Article XXV "Administrator;" insert Article XXVII "Counterpart;" and renumber Article XXVII "Entire Agreement;" and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #4244 shall be amended a first time as follows:

1) Article II, Term shall be amended in its entirety to read as follows:

**ARTICLE II**

**Term:** The Agreement 4244 became effective on October 22, 2019 for one year, and shall be extended an additional year. The amended extension to the term shall become effective upon final execution by all parties hereto and shall expire October 21, 2021, unless terminated earlier pursuant to the provisions contained herein this Agreement under the Article(s) titled, "Default, Termination, and Cancellation" or "Fiscal Considerations."

2) Article XXV, Administrator, shall be amended and replaced in its entirety to read as follows:

**ARTICLE XXV**

**Administrator:** The County Officer or employee with responsibility for administering this Agreement is Patty Moley, Assistant Director, Health and Human Services Agency, or successor.

3) Article XXVII, Entire Agreement, shall be amended to insert Counterpart as follows:

ARTICLE XXVII

Counterpart: This Agreement may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Agreement and all of which, when taken together, will be deemed to constitute one and the same agreement.”

4) Article XXVII “Entire Agreement” is hereby renumbered as follows:

ARTICLE XXVIII

Entire Agreement: This document and the documents referred to herein or exhibits hereto are the entire Agreement between the parties and they incorporate or supersede all prior written or oral Agreements or understandings.


Except as herein amended, all other parts and sections of that Agreement #4244 shall remain unchanged and in full force and effect.
