



**RESOLUTION No. 233-2014**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**  
**RESOLUTION OF INTENTION TO AMEND THE EL DORADO COUNTY CODE**

**WHEREAS**, on November 15, 2011, the Board of Supervisors adopted urgency Ordinance No. 4968 imposing a 45-day moratorium on the outdoor cultivation of medical marijuana; and,

**WHEREAS**, on December 20, 2011, the Board of Supervisors adopted Ordinance No. 4970, extending that ordinance through November 6, 2012; and,

**WHEREAS**, on October 30, 2012, the Board of Supervisors adopted Ordinance No. 4986, further extending the ordinance through October 30, 2013; and,

**WHEREAS**, on September 24, 2013, the Board of Supervisors adopted Ordinance No. 5000 adding Section 17.14.260 of Chapter 14 of Title 17 of the El Dorado County Ordinance Code establishing regulations for the outdoor cultivation of medical marijuana; and,

**WHEREAS**, since the adoption of Ordinance 5000, the County has experienced a significant increase in the number and size of marijuana cultivation operations, directly impacting and threatening public safety, the environment, and the health and welfare of the community.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Supervisors of the County of El Dorado will set a public hearing to consider amending the El Dorado County Code, pursuant to Chapter 1.04 and Section 17.10.010, to repeal Section 17.14.260 of Chapter 14 of Title 17 which established regulations for the outdoor cultivation of medical marijuana; and,

**BE IT FURTHER RESOLVED**, the Board of Supervisor hereby authorizes the Community Development Agency, Development Services Division to proceed with the preparation for the above-said hearing.
