RESOLUTION NO. 108-2016

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO
AMENDING FEES FOR BUSINESS LICENSES
(Supersedes Resolution 179-2003)

WHEREAS, Section 16100 of the California Business and Professions Code and Title 5 – Business Taxes, Licenses and Regulation, Chapter 5.16 – Fees, Section 5.16.010 – General Fee, of the El Dorado County Ordinance Code, provides for the Board of Supervisors to establish a fee for the privilege of operating a business in the unincorporated territory of the County of El Dorado; and

WHEREAS, the Board of Supervisors of the County of El Dorado adopted resolution 179-2003 on July 8, 2003, establishing business license fees for businesses operating within the unincorporated territory of the County of El Dorado; and

WHEREAS, substantial changes have occurred since July 2003, affecting the cost of issuing business licenses, and the Board of Supervisors desires to replace its resolution;


NOW, THEREFORE, BE IT RESOLVED that the business license fees for those businesses listed below are hereby amended to be as follows:

	<u>Fee Amount</u>
A - All business, except for those listed separately	\$ 42.00
B - Door-to-door soliciting and selling (itinerant businesses)	42.00
C - Fortunetelling	140.00
D - Carnivals	140.00
E - Secondhand dealers and pawnbrokers	140.00
F - Automobile, bicycle, or motorcycle races	42.00
G - Christmas trees or holly berries	20.00
H - Gunpowder, dynamite, or other explosive substances	42.00
I - Professional prize fighting or wrestling	42.00
J - Shooting match or turkey shoot	42.00
K - Theatrical performances	42.00
L - Games of skill	42.00
M - Dances	42.00
N - Dog, horse, or trained animal shows	42.00
O - Ski tows	42.00
P - Music playing machines, mechanical amusement machines, vending machines	42.00
Q - Community antenna television systems	42.00


This resolution shall take effect thirty (30) days after its adoption.
