

CONTRACT FOR SERVICES #760321-01
AMENDMENT I

This Amendment I to Contract No. #760321-01 is made and entered into by and between the Golden Sierra Job Training Agency ("GSJTA") and the El Dorado County Human Services Department Community Action Agency representing the El Dorado One Stop Operator Consortia ("CONTRACTOR").

W I T N E S S E T H

WHEREAS, County has been engaged by GSJTA to provide WIA operations/activities, in accordance with Contract No. #760321-01, dated August 22, 2006, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of said Contract for thirteen (13) additional months to July 31, 2008, hereby amending **SECTION 4 – Term** and;

WHEREAS, the parties hereto have mutually agreed to amend **SECTION 5 – Fund Levels** for the period July 1, 2007 through June 30, 2008, and

WHEREAS, the parties hereto have mutually agreed to amend **EXHIBIT A - SECTION 1 Notices**, and

WHEREAS, the parties hereto have mutually agreed to amend **EXHIBIT B – SECTION 10 One-Stop Principles Bullet 14** to include the identification of participating partners in any and all published marketing materials developed by the County or its Sub-Contractors for any provision of services funded under this contract which includes identifying the Golden Sierra Workforce Investment Board as the funding agent for the marketed activities;

NOW THEREFORE, the parties do hereby agree that Contract #760321-01 shall be amended a first time as follows:

SECTION 4

Term: This Agreement, as amended, shall become effective upon execution by both parties hereto and shall cover the period of July 1, 2006 through July 31, 2008.

SECTION 5 – Fund Levels for the term July 1, 2006 through June 30, 2007 Funding Levels were agreed as follows:

Adult	\$271,581
Youth	\$147,598
Dislocated Worker	\$201,331
Rapid Response	\$100,000
Total Contract	\$720,510

For the term July 1, 2007 through July 31, 2008 GSJTA will amend Section 5 to identify funding as appropriate for the continuation of services at 50% of the aforementioned levels until such time that the WIA allocations for our region are issued and an actual funding level is negotiated, and agreed to by both parties, as published in the final budget for this contract; and

SECTION 5A

Payment and Reporting: The GSJTA shall reimburse the County for services performed under this Agreement. Each payment shall be made after timely presentation by the County of an invoice, no later than **fifteen (15) calendar days** after the end of each month. Each invoice submitted shall be subject to review and approval by the Agency and must be substantiated by such detailed itemization as required by the Agency. The County is responsible for the allocation of expenditures based on the above funding streams and for insuring that funding limitations and WIA guidelines regarding program activities are adhered to.
