OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RESOLUTION FOR EL DORADO COUNTY PARK FEES

WHEREAS, current park fees are governed by El Dorado County Board of Supervisors Resolution 213-90 and the fees set forth therein need to be revised to reflect updated County costs;

WHEREAS, As the County Park system builds recreation facilities, the need for administration, maintenance and operation of these facilities grows;

WHEREAS, the County parks will need revenue for administration, maintenance and operation of these County facilities and support from park users; and

WHEREAS, the revenue needed to maintain and operate park facilities should be partially provided by those members of the public that utilize the facilities; and

WHEREAS, facility users and uses differ;

Therefore the following shall be the fee schedule and policy for the County park facilities superseding the aforesaid Resolution 213-90:

PIONEER PARK FACILITY USE FEES:

Equestrian Arena Use Fees

Class I - Organized and supervised youth groups pay a **\$10** processing fee per reservation. A **\$30** fee will be assessed for groups wishing to use the arena for reserved, ongoing practices.

Class II - Adult equestrian associations and clubs pay a **\$150** fee for a season use permit. It should be noted that a season use permit is for a six month period.

Class III - Clinics that promote proper horse care pay a **\$50** fee and/or a percentage of gross receipts, whichever is greater. (Refer to "Doing Business In the Park" policy.)

Class IV - Special Events charging general admission will be charged a **\$150** use fee (**\$200** for a two day event) and a percentage of gross receipts. For profit organizations must pay the County 15% of gross receipts.

WORK SERVICES IN LIEU OF USER FEES:

When member of the public and/or organized leagues wish to provide work services at the parks in lieu of special event or field use fees, a proposal for these services shall be presented to the El Dorado County Parks and Recreation Commission for review and approval prior to the event. The Commission will determine whether services offered are of a value similar to the fees charged. The refundable damage deposit is not subject to this fee waiver option.
