

RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, in accordance with Government Code Section 29007, the Board of Supervisors must approve a schedule establishing the number of allocated positions and salary ranges by classification as part of its adopted budget; and

WHEREAS, in accordance with Section 602 of the County of El Dorado Personnel Rules Resolution #166-2022, the Board of Supervisors shall, by Resolution, specify the number and classification of all authorized positions for each department of the County; and

WHEREAS, in accordance with Section 602 of the County of El Dorado Personnel Rules Resolution #166-2022, the Board of Supervisors annually, upon recommendation by the Chief Administrative Officer, may approve an extension of the underfill of an authorized position with a related classification that has a lower salary range beyond the next budget cycle; and

WHEREAS, in accordance with Section 1105 of the County of El Dorado Personnel Rules Resolution #166-2022, a limited term appointment is an at-will appointment in the unclassified service made to an approved limited term allocation which has a fixed expiration date. Limited term appointments, unless earlier terminated, terminate automatically at the end of the specific project for which the appointment is made; and

WHEREAS, on March 12, 2025, the Board of Supervisors adopted Resolution 036-2025, which approved the dissolution of the Criminal Attorney bargaining unit, the establishment of a new Attorney classification series, and associated reclassifications and position allocations; and further authorized a variance to Personnel Rule 505 to allow the District Attorney, Public Defender, and Alternate Public Defender to temporarily underfill or overfill Deputy and Sr. Attorney positions for up to two years, in order to support phased recruitment and internal advancement needed to meet operational and staffing objectives; and

WHEREAS, Resolution #105-2024 established the authorized Personnel Allocation based on the Fiscal Year 2024-25 Recommended Budget and has been subsequently modified by action of the Board; and

WHEREAS, modifications to the Authorized Personnel Allocation are necessary as a result of the budget process for Fiscal Year 2025-26, including the elimination of certain filled positions through a Reduction in Force (RIF) to ensure the fiscal integrity of the budget; and

WHEREAS, reductions in filled positions have been informed by information provided by the Department Head of each impacted Department as to the operational needs of said Department; and

WHEREAS, the Reduction in Force associated with the Fiscal Year 2025-26 Budget will eliminate a total of 11.0 full-time equivalent (FTE) filled positions, and 28.2 FTE vacant positions; and

NOW, THEREFORE, BE IT RESOLVED, the number and classification of all authorized positions in each County department is set forth as shown in Exhibit A, effective July 1, 2025, such Exhibit A incorporating the allocation changes resulting from the budget process for Fiscal Year 2025-26 and amendments previously made to Authorized Personnel Allocation Resolution #105-2024.

BE IT FURTHER RESOLVED, that this Resolution hereby incorporates, by reference, the El Dorado County Salary Schedule effective May 14, 2025, as published on the Human Resources website, providing the salary rate or range, as applicable, for all allocated positions.

BE IT FURTHER RESOLVED, that, unless a Limited Term allocation is earlier terminated or the expiration date is extended by action of the Board, after the expiration date indicated in Exhibit B, the allocations specified in Exhibit B shall automatically expire, and the then-current Limited Term allocation of this job class within the department shall automatically be reduced by the applicable Limited Term FTEs, with the then-current Authorized Personnel Allocation Resolution thereby amended accordingly as of the expiration date.

BE IT FURTHER RESOLVED, the Board of Supervisors hereby approves the following new underfill arrangement for Fiscal Year 2025-26:

BE IT FURTHER RESOLVED, that the Director of Human Resources is hereby authorized to make any technical corrections as needed to implement the provisions of this Resolution.

BE IT FURTHER RESOLVED, the Reduction in Force with respect to currently filled positions shall be effective July 11, 2025, consistent with the applicable provisions of the County's Memoranda of Understanding, with the majority of affected positions to be removed from department personnel allocations as of that date. The last working day for affected employees will be July 10, 2025, with the majority of positions to be removed from department personal allocations as of July 11, 2025. One additional position in the Chief Administrative Office shall be removed from allocation effective January 10, 2026.

BE IT FURTHER RESOLVED, that the Director of Human Resources is directed to administer the RIF process in accordance with the County's Personnel Rules, the Salary and Benefits Resolution, and the terms of all applicable agreements with the affected employee bargaining units.

BE IT FURTHER RESOLVED, that effective Saturday, January 10, 2026, one Enterprise Resource Planning Analyst (1.0 FTE) in the Chief Administrative Office shall be deleted as part of this RIF.
