

Beginning on the northerly right of way line of Pony Express Trail at its intersection with the southeast corner of that particular parcel described in Document No. 2001-0044472 official records said county and state, from which the northeast corner of said Section 3 bears North 21° 34' 58" East 1292.39 feet; thence from said POINT OF BEGINNING along the easterly line of said parcel North 00° 01' 59" East 34.26 feet; thence leaving said line along the southerly lines of Lot 10 and Lot 11, Block I of that certain Subdivision Map filed in Book A of Subdivision Maps at Page 22, official records said county and state North 80° 35' 48" East 101.37 feet; thence North 67° 47' 15" East 100.95 feet; thence North 55° 41' 14" East 142.38 feet; thence leaving said southerly line North 54° 44' 31" East 31.95 feet to the most southerly point of Lot 1, Block H of said subdivision; thence along the easterly line of said Lot 1 North 53° 41' 25" East 56.00 feet; thence leaving said line South 86° 04' 00" East 25.59 feet to the easterly line of said Section 3; thence along said easterly line South 03° 56' 00" West 67.38 feet to said northerly right of way line of Pony Express Trail; thence leaving said easterly line along said northerly line South 64° 23' 59" West 210.95 feet; thence South 74° 04' 59" West 221.46 feet to the POINT OF BEGINNING containing 17914 square feet or 0.41 acres more or less. 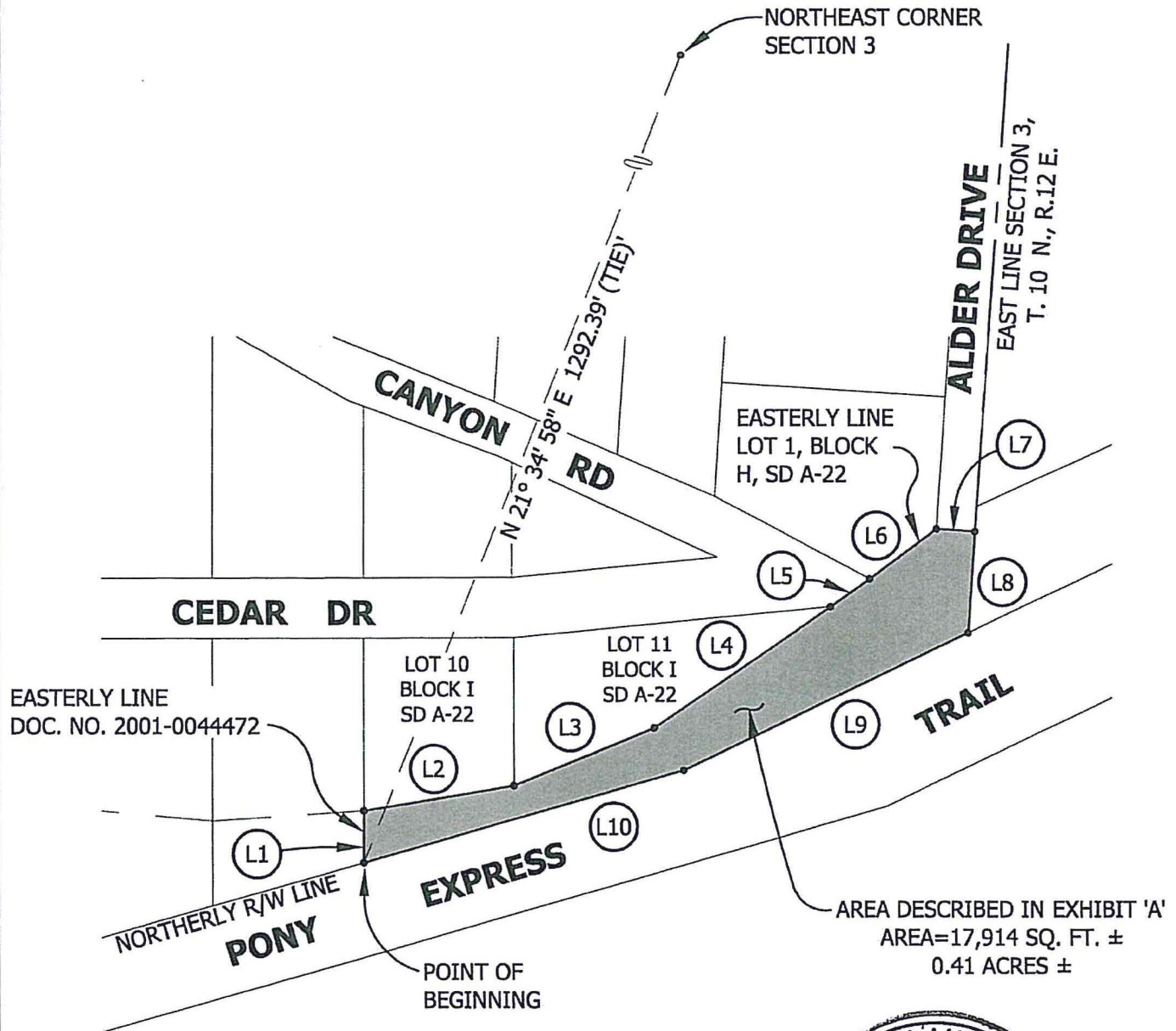
