IMPORTANT CURRENT REQUIREMENTS

Participants are required to reserve their days of attendance in advance. The fee is also to be paid in advance of services.

IMPORTANT NEW REQUIREMENTS

A Functional Assessment will be conducted prior to enrollment and every six months thereafter, or upon significant observed changes in functional capacity. This Functional Assessment will determine the Level of Care (LOC) required ranging from LOC 1 to LOC 3. There will be no additional charge for LOC 1. A daily surcharge of \$3 for LOC 2 and \$5 for LOC 3 will be applied.

Participants are required to reserve their days of attendance in advance, except for respite care which is available on a first-requested, first-served basis dependent on availability of space and staff. The fee is also to be paid in advance of services.

Fees in each category may be increased by \$1.00 to \$5.00 on July 1st and January 1st commencing July 1, 2009 upon Director approval.
