Veteran Memorial Foundation

Official name of the foundation is clarified as the Friends of the Memorial Monument. Commission confirmed \$150 to be payable to the Friends of the Memorial Monument for 2009 and an additional \$150 for 2010 to bring the total to \$300 for flower wreath display during Memorial and Veterans Day; the Commission also issued a challenge to local service organizations to match the donation.

Discussion to include Welcome Vietnam Veterans Day (March 30) as passed as AB264 in September 2009 - "AB264 - Would require the Governor to annually proclaim March 30 of each year as "Welcome Home Vietnam Veterans Day" and would encourage schools to conduct exercises to recognize the contributions of those involved in the Vietnam conflict".

Ordinance 4743 – County Veterans Monument designates Memorial and Veterans Day as authorized events.
