FIRST AMENDMENT TO AGREEMENT FOR SERVICES #145-S1711

THIS FIRST AMENDMENT to that Agreement for Services #145-S1711 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Dario Mancio, a sole proprietor duly qualified to conduct business in the State of California, whose principal place of business is 3960 Cedar Ravine Road, Placerville, California 95667, (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide on-call gardening and landscape maintenance services at the Placerville Union Cemetery for its Community Development Services, Administration and Finance Division, pursuant to Agreement for Services #145-S1711, dated September 30, 2016, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to increase the not-to-exceed compensation amount of the Agreement by \$28,000, amending **ARTICLE III, Compensation for Services**;

WHEREAS, the parties hereto desire to update County's notice recipient, amending **ARTICLE XXI, Notice to Parties**;

WHEREAS, the parties hereto desire to update County's Contract Administrator, amending **ARTICLE XXXVII, Contract Administrator**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

- I. All references to Community Development Agency throughout the Agreement are substituted with Community Development Services.
- II. **ARTICLE III, Compensation for Services**, paragraph 3 of the Agreement is amended to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$65,000, inclusive of all costs and expenses.
- III. **ARTICLE XXI, Notice to Parties**, of the Agreement is amended in its entirety to read as follows:

ARTICLE XXI

Notice to Parties: All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to County shall be in duplicate and addressed as follows:


- V. **ARTICLE XXXVII, Contract Administrator**, of the Agreement is amended in its entirety to read as follows:

ARTICLE XXXVII


