RESOLUTION OF INTENT TO INCREASE THE BENEFIT ASSESSMENT FOR THE
BARNETT BUSINESS PARK LIGHTING ZONE OF BENEFIT #98534 WITHIN COUNTY
SERVICE AREA #9

WHEREAS, the Board of Supervisors of the County of El Dorado formed County Service Area #9 pursuant to Title 3, Division 2, Part 2, Chapter 2.2 of the California Government Code; and

WHEREAS, the Board formed Barnett Business Park Lighting Zone of Benefit #98534 on October 7, 1986 by Resolution 316-86 for the purpose of providing street lighting services; and

WHEREAS, the boundaries of the Barnett Business Park Lighting Zone of Benefit #98534 are as described in Exhibit A and shown in Exhibit B; and

WHEREAS, California Government Code §25210.77a expressly authorizes a zone within a county service area to levy benefit assessments for providing extended county services; and

WHEREAS, the *Policy and Procedure Guidelines for Creation and Administration of Zones of Benefit within a County Service Area, Amended June 2, 1987* require that the benefit assessment collected shall be in an amount sufficient to pay for the proposed services, including administrative and miscellaneous costs incurred in providing such services; and

WHEREAS, pursuant to California State Law, the benefit assessment amount is calculated in the Engineer's Report; and

WHEREAS, the Board, acting as the Governing Body of County Service Area #9 has reviewed and accepts the Engineer's Report; and

WHEREAS, if no majority protest exists, the Board intends to increase the benefit assessments for Barnett Park Lighting Zone of Benefit to the amount supported by the Engineer's Report, and

WHEREAS, California State Law requires approval by the owners of property within a zone of benefit through an assessment ballot proceeding in order for a benefit assessment to be increased.

NOW, THEREFORE, BE IT RESOLVED

1. The Board authorizes the commencement of an assessment ballot proceeding for the owners of property within the zone of benefit boundaries to consider an increase to the benefit assessment for the Barnett Business Park Lighting Zone of Benefit #98534;
2. The Board shall conduct a public hearing on July 29, 2008 at 10:00 a.m. at which the assessment ballots will be tabulated;
3. If a majority protest is heard against the proposed increase to the benefit assessment in Barnett Business Park Lighting Zone of Benefit #98534, the assessment will not be increased, but will continue to be collected at the existing annual rate of \$61.00 per parcel.
