
**Fiscal Impact:** None. We have sufficient money in our budget to pay for this proposed expenditure.

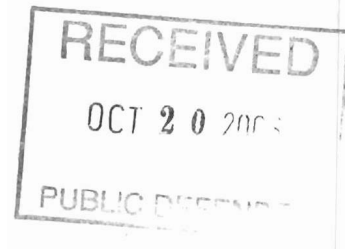
