Judges Comments (5 minutes) Judge Mayberry talked about the recent upward trend in assault cases particularly in schools on the West Slope. Generally between classmates - noted coping with anger skills

She mentioned she reached out to the Courts Administration to get more involved with the JJDPC.

Juvenile Treatment Center - Assistant Deputy Chief Probation Officer (5 min) ADCPO Borovich: Update at the JTC - Both pods new carpet is being installed and removing metal bolted to the ground tables. Getting more "softer furniture" for a home feel. Recent BSCC Evaluation went really well - excellent feedback with zero issues of noncompliance. Currently there are 9 males and 2 females and no SYTF. Requested the 2024 JJDPC Inspection and reports due by June 30, 2024. JJDPC scheduled this for June 2, 2024. There is a Ribbon Cutting Ceremony for the Lake Room (new Multi-Sensory De-escalation Room at the JTC) on June 20, 2024
