Region Builders announced that it spent \$80,000 to hire paid signature gatherers. The petition process was tainted by the aggression displayed by the Region Builders' signature gatherers, who harassed and intimidated our citizen volunteers, shouted lies, and aggressively displaced our citizen volunteers from spaces we reserved with permission of store owners. Indeed, the full-page ads in the newspaper meant to confuse voters and the co-opting of our grassroots group name is nefarious and is disappointing coming from the El Dorado County Chamber of Commerce PAC (who funded Region Builders), considering that county taxpayer money provides the COC with a great deal of funding, and the COC is working against the community citizenry and their democratic right to place an initiative on the ballot.

The community is speaking to you on this, and expects that you will make the appropriate decision by allowing the citizens a seat at the table and a voice in shaping the future of our county. There is great distrust on the part of the citizens that El Dorado County government is not responsive to the citizens of the county and is only responsive to the developers and monied special interests. You have the opportunity before you to regain trust. I hope you choose wisely.
