OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RESOLUTION ESTABLISHING THE ANNUAL BENEFIT ASSESSMENT FOR THE 2007/08 TAX YEAR FOR SNOW REMOVAL SERVICES WITHIN COUNTY SERVICE AREA #3,

WHEREAS, the Board of Supervisors of the County of El Dorado has formed County Service Area #3 pursuant to Title 3, Division 2, Part 2, Chapter 2.2 of the California Government Code and within that County Service Area established zones of benefit; and

WHEREAS, snow removal is an allowable extended county service pursuant to Government Code \$25210.1; and

WHEREAS, the benefit assessments in the amounts shown on Exhibit A have been collected in fiscal year 2006/07 for the purpose of providing snow removal services within the zones of benefit in the unincorporated areas of the County; and

WHEREAS, the Board of Supervisors of the County acting as the governing board of County Service Area #3 finds that the benefit assessments are apportioned to the estimated benefit derived from the special services provided within each zone; and

WHEREAS, election or majority ballot procedure pursuant to Proposition 218 is not required to continue the existing benefit assessments for fiscal year 2007/08 at the same or lower amounts; and

WHEREAS, a public hearing was scheduled on June 12, 2007 and was noticed as required by Government Code §25210.77a; and

WHEREAS, on June 12, 2007 after public hearing, the Board determined that no majority protest has been registered against establishing the proposed assessments within the zones of benefit.

NOW, THEREFORE, BE IT RESOLVED that the Board determines as follows:

 The benefit assessments as shown on Exhibit A shall be levied and collected for the fiscal year 2007/08.

- The benefit assessments shall be distributed in accordance with the final budgets for the zones, as approved by the Board of Supervisors during County budget hearings and amendments thereto.
- The services to be provided are extended county services as defined on County Service Area Law, Government Code \$25210.1.
- 4. The benefit assessments levied and collected are apportioned according to the estimated benefit derived from the snow removal services provided within each zone.
- 5. The benefit assessments are a continuation of the previous benefit assessments in the same or lower amounts.
- The levy and collection of the benefit assessments is exempt from election or majority ballot procedure under Proposition 218.

BE IT FURTHER RESOLVED, that the assessments as adopted and confirmed shall appear as a separate item on the tax bill for each parcel and shall be levied and collected in the same manner as County ad valorem taxes are collected, as more specifically set forth and authorized on subdivision (d) of §25210.77a of Government Code.
