NOTICE OF PUBLIC HEARING The County of Ei Dorado Board of Supervisors will hold a public hearing in the Supervisors Meeting Room, 330 Fair Lane, Piacerville, CA 95867 on April 19, 2011, at 2:00 p.m., to consider Site Plan Review SPR11-0001/Coioma Blues Livei Music Festivai submitted by EL DORADO ARTS COUNCIL for a site plan review to allow a one day music festival with an restimated attendance of 3,000 people and off-site parking. The music festival is proposed for Saturday, June 4, 2011, from 10:00 a.m. to 7:00 p.m. Off-site parking will occur on properties identified by Assessor's Parcel Numbers 006-011-75, 006-341-14, and 1989-030-23 (The remainder of the parking facilities are on parcels outside of the County's jurisdiction.).
