Judge's Comments (5 minutes) -

Judge Mayberry was in attendance and talked about her support for the commission.

Juvenile Treatment Center Superintendent (5 minutes) -

Current Staffing: One Vacancy with one candidate already in line to fill, 2 Probation Assistant positions - 2 candidates in backgrounds to fill these positions. Noted the heat is currently being installed in the recreational area. Current Population at the JTC: 7 - no females at this time. One SYTF just started his courses at Chico and was appreciative of the new laptop and printer he received from the JJDCP which has made his virtual classes easier. JTC installing a De-Escalation Room. Working with partners to design this space to meet the needs of youth. Should be complete in the next few months. Probation partnering with EDCOE and NCCT for training opportunities with youth.

#### **Chief Probation Officer (10 minutes)**

Probation Deputies were in the process of transitioning from OC Spray to a new Presidia Gel that can decontaminate within min/sec. There were issues with the testing of this new gel product. Probation is working to resolve these issues with the company but in the mean time, the use of this new gel has been suspended and OC Spray is used. Probation is using a new Def. Tact. De-Escalation Training which is less aggressive and will equate to far fewer accidents with training and in the facility. Reduce/eliminate injury for youth and staff. Chief RIchart recently appointed to the BSCC by Gov. Newsom (one of two CPOs- population under 200K (38 counties)). CPO Richart is part of the Juvenile Justice Sub Council of Child Welfare to assist OYCR and Child Welfare includes Tulare Co. Imperial Co. and El Dorado Co. Also discussed Title 15 Steering Committee with (4) subcommittees and the collaboration with Mr. Reynolds from Rising Stars at LTCC for post secondary education for youth in institutions.
