The County of El Dorado Planning Commission will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on January 23, 2020, at 8:30 a.m., to consider the following: Conditional Use Permit CUP19-0004/Kelli's Love For Labs Dog Kennel submitted by KELLI DRAGON to allow the operation of a private dog kennel for up to 10 Labrador Retriever dogs as an expanded home occupation. The property, identified by Assessor's Parcel Number 077-040-011, consisting of 5.36 acres, is located on the southwest side of Newtown Road, approximately one mile northwest of the intersection with Fort Jim Road, in the Placerville area, Supervisorial District 3. (County Planner: Tom Purciel, 530-621-5903) (Categorical Exemption pursuant to Section 15303 of the CEQA Guidelines)*

Rezone Z19-0001/Tentative Parcel Map P19-0001/Paye submitted by MILLENNIUM PLANNING & ENGINEERING to allow a Rezone of a 103.6 acre parcel from Open Space (OS) to Residential Estate Five-Acres (RE-5), and a Tentative Parcel Map creating four new residential parcels ranging in size from 5.6 to 7.1 acres and one 78.4 acre remainder parcel, including an offer to the County for 1.51 acre parcel containing Wentworth Springs Road County maintained right of way. The property, identified by Assessor's Parcel Number 061-071-026, consisting of 103.6 acres, is located on the north and south side of Wentworth Springs Road, at the intersection with Raintree Road, in the Georgetown Rural Center, Supervisorial District 4.
