Resolution to Vacate a Portion of Old Highway 49

Background

On April 29, 2008, the El Dorado County Board of Supervisors approved Resolution No. 87-2008, a Resolution of Intention to Vacate a Portion of Old Highway 49. Said Resolution set a public hearing date of May 20, 2008, at 9:00 AM in the Board of Supervisors chambers, for the purpose of taking public testimony on the proposed General Vacation. Pursuant to Streets and Highways Code Section 8322 (a), notice of said Public Hearing was to be published at least two consecutive weeks prior to the established hearing date; an error in the publishing by the Mountain Democrat Newspaper of the Public Hearing date as required by Section 8322 (a) now requires that the Public Hearing date be re-established as June 3, 2008. As a further consequence, County Counsel has advised that the Board of Supervisors should also approve amending Resolution No. 87-2008 to set the Public Hearing date as June 3, 2008.

Recommendation

The Department of Transportation recommends:

- 1) The Board of Supervisors continue the Agenda Item and Public Hearing scheduled for May 20, 2008, to the meeting of June 3, 2008, at 9:00 AM, in the Board of Supervisors Chambers.
- 2) Authorize the amendment to Resolution No. 87-2008, to change the date of the Public Hearing from May 20, 2008 to the date of June 3, 2008.

Action to be Taken Following Board Approval:

- 1) Board Clerk to continue the Agenda Item and Public Hearing to June 3, 2008, at 9:00 AM.
- 2) Board Clerk to note the amendment to Resolution No. 87-2008, to change the Public Hearing date from May 20, 2008 to June 3, 2008.
