

**AGREEMENT FOR SERVICES 003-S1310
AMENDMENT I**

Heating and Air Conditioning System Design, Installation, and Repair Services

This Amendment I to that Agreement for Services 003-S1310, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Ski Air Incorporated, a California Corporation, duly qualified to conduct business in the State of California (hereinafter referred to as "Contractor"), whose principal place of business is 5528 Merchant Circle, Placerville, CA 95667 (Mailing: P.O. Box 1054, El Dorado, CA 95623); and whose Agent for Service of Process is Michael Leonard Lubinski, 5528 Merchant Circle, Placerville, CA 95667;

RECITALS

WHEREAS, Contractor has been engaged by County to provide heating and air conditioning system design, installation, and repair services on an "as requested" basis for the Health and Human Services Agency ("HSSA") in accordance with Agreement for Services 003-S1310, dated May 31, 2012; incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to amend **Article III – Compensation for Services**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services 003-S1310 shall be amended a first time as follows:

Articles III is amended in its entirety to read as follows:

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Contractor in a lump sum payment within forty-five (45) days following County's receipt and approval of itemized invoice(s) that details the services rendered and identifies the name of the Program for which said services were provided. Prior to the commencement of any work, Contractor shall provide a written estimate of the work to be performed and obtain written approval from a HHSA Program Supervisor or Program Manager. The County shall not pay for unauthorized services.

The total amount of this Agreement shall not exceed \$90,318.00.

Except as herein amended, all other parts and sections of that Agreement 003-S1310 shall remain unchanged and in full force and effect.
