Why do you seek appointment? I am seeking an appointment with the El Dorado County Child Abuse Prevention Council because I feel strongly that the children of our county are some of our most valuable assets. With that, the safety of our kids is paramount. I believe all children in our county should have the right to be free of all types of abuse. I also believe that education is the primary key to knowledge and knowledge is the primary key to prevention. Providing children with knowledge based on prevention skills and support is one of the main tactics of deterrence.
