•Treasurer's Report

Hurley provided copies of three versions of the El Dorado Community Foundation Statement. Doesn't see in either statement where funds were transferred to the Dunlap Fund (2022) and sent an email to the Foundation for clarification. Discussion around clarification in the consolidation of this.

Request made by Guerrero of the Commission – name ideas for the Dunlap Fund – Commission members email up to 2 names suggestions for consideration.
