I would like to submit a public comment pertaining to the 6/29 BOS Agenda Item #41 – File #21-1039:

I 100% support adopting the resolution proposed removing any mandatory masking/vaccination rules in the schools. This is a very easy decision and if the BOS does not vote in favor of it, that will be a clear indication that they also do not support our constitutional and God-given rights. We will take action if that's the case.

Also of note:

1. Masks are approved for use under an EUA - - so that means informed consent must be given which involves the option to REFUSE. There are no randomized, controlled trials (RCT) with verified outcomes that shows a benefit to healthcare workers or community members for wearing a mask or a respirator. There is no such definitive study. No study exists that shows a benefit from a broad policy to wear masks in public.
  2. Masks can't possibly work -- Coronaviruses are <0.125 microns in size. Masks and respirators only filter particles .30 to .80 microns in size
  3. Masks involve health risks that all users need to be aware of (again informed consent) -- A group of parents in Florida recently had testing done on masks worn by their kids for 6 hours one day and found 21 pathogenic strains that cause such issues as pneumonia, meningitis, Lyme disease, Legionnaires' disease. No SARS-CoV-2 was found. <https://rationalground.com/dangerous-pathogens-found-on-childrens-face-masks/>
  4. Now for the Constitution....NO health order, NO emergency order, NO state of emergency, NO municipal ordinance or school "policy" may suspend the Constitution or violate those rights/freedoms. A law, mandate, policy or regulation that has been passed that is violation of these rights thus becomes null & void.
- US Constitution/1<sup>st</sup> Amendment (Right to Religious Express) – My religious freedom grants me the right to NOT have my child wear a mask.
  - US Constitution/4<sup>th</sup> Amendment (Right to Privacy) – Required masking, taking temperatures and asking about vaccine status all violate this amendment.
    - CA Constitution/Article 1, Section 1: All people are by nature free and independent and have inalienable rights. Among these are enjoying and defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy. Required masking & vaccination would not allow for this freedom.
    - CA Constitution/Article 1, Section 4: Free exercise and enjoyment of religion without discrimination or preference are guaranteed. Masking & vaccination again violate this freedom.

I hope you remember that you represent the people, and it is your responsibility & DUTY to protect their rights and freedoms.

My grandchild attends Oak Ridge H.S. therefore I have a personal stake in the debate over masking in the El Dorado County schools.

My grandchild's step-father and other grandparents are Republicans. During the majority of the past year, they were more careful about Covid precautions than most DEMOCRATS I know. They spent months sheltering in place, and enforced strict quarantines of 2 weeks on any family members who chose to go out. **I write to request that you end the mandatory mask wearing for students and educators in the schools. I am both an educator in the Buckeye Unified School District and a parent of three children in the District. I have been vaccinated, as has my age eligible child. But children are not spreaders of this virus. I taught the entire last year in a mask, with children in mask. We did great but it's time to end this. We have a vaccine available for the susceptible persons. Our children and teachers deserve to breathe and see the smiles that keep us going through all this.**

**The CDC's mandate that children as young as 2-years-old must wear facemasks is among the most stringent face mask age requirements in the world. For example, in Switzerland, children under the age of 12 do not have to wear a mask. In the UK and France, children under the age of 11 are exempt. And in Italy, the exemption applies to children under the age of six. The significantly lower age requirement for mask wearing in the United States raises questions about the susceptibility of young children to COVID-19, the rate at which they transmit the disease, and their developmental ability to comply with mask requirements.**

**Within the United States, children younger than age five account for approximately six percent of the population but only two percent of total coronavirus cases. Further, according to the Association of American Medical Colleges, "Several studies have found that children transmit the virus, but perhaps not as often as adults, especially in younger age groups." National Institute of Allergy and Infectious Diseases Director Dr. Anthony Fauci made a similar assessment in November 2020, stating, "If you look at the data, the spread among children and from children is not really very big at all, not like one would have suspected."**

**One review of scientific literature on COVID-19 infections showed "evidence for significantly lower susceptibility to infection for children aged under 10 years compared to adults given the same exposure." Another review that focused on contact-tracing studies and population-screening studies found**

**“preliminary evidence that children and young people have lower susceptibility to SARS-CoV-2, with a 56% lower odds of being an infected contact.” A different analysis of 32 studies indicated that “children and adolescents younger than 20 years had 44% lower odds of secondary infection with SARS-CoV-2 compared with adults 20 years and older; this finding was most marked in those younger than 10 to 14 years.”**
