

**FOURTH AMENDMENT TO
AGREEMENT TO MAKE SUBDIVISION IMPROVEMENTS
FOR CLASS 1 SUBDIVISION
BETWEEN COUNTY AND OWNER**

THIS FOURTH AMENDMENT, to that certain Agreement to Make Subdivision Improvements for Class 1 Subdivision Between County and Owner (hereinafter referred to as the "Agreement"), made and entered by and between the **COUNTY OF EL DORADO**, a political subdivision of the State of California, (hereinafter referred to as "County"), and **PROMONTORY CONSTRUCTION COMPANY, LLC**, a California limited liability company duly qualified to conduct business in the State of California, whose principal place of business is 7919 Folsom Boulevard, Suite 300, Sacramento, California 95826 (hereinafter referred to as "Owner"); concerning **PROMONTORY VILLAGE 7 - UNIT 5, TM 16-1530** (hereinafter referred to as "Subdivision"); the Final Map of which was filed with the El Dorado County Board of Supervisors on the 20th day of April, 2021.

RECITALS

WHEREAS, County, and Owner entered into that certain Subdivision Improvements Agreement on April 20, 2021, entered into the First Amendment to the Agreement on November 8, 2022, entered into the Second Amendment to the Agreement on March 13, 2024, and entered into the Third Amendment to the Agreement on March 5, 2025, in connection with the Subdivision, copies of which Agreement, First Amendment, Second Amendment, and Third Amendment are incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement"); and

WHEREAS, the Agreement, as amended, requires Owner to complete the subdivision improvements thereunder on or before April 20, 2026, and Owner has not completed all of the improvements but has requested an extension of time to complete the subdivision improvements on or before April 20, 2027, subject to the terms and conditions contained herein;

NOW, THEREFORE, the parties hereto, in consideration of the recitals, terms, and conditions herein, do hereby agree to amend the terms of the Agreement in this Fourth Amendment to read as follows:

I. Section 3 is amended to read as follows:

3. Complete the Subdivision improvements contemplated under this Agreement on or before April 20, 2027.


Except as herein amended, all other parts and sections of that certain Agreement dated April 20, 2021, shall remain unchanged and in full force and effect.
