

**FIRST AMENDMENT TO AGREEMENT FOR
ACCESS TO THE COUNTY OF SACRAMENTO'S
CLETS/CJIS APPLICATIONS**

This AMENDMENT is made and entered into as of this 28th day of October, 2008 between the COUNTY OF SACRAMENTO, a political subdivision of the State of California, hereinafter referred to as COUNTY and the COUNTY OF EL DORADO POLICE DISTRICT, herein referred to as AGENCY. The COUNTY and AGENCY hereby amend the agreement entered into between the parties on July 1, 2008 ("Agreement"). The agreement is identified by AGENCY as contract number 816-S0811.

It is the intent of the COUNTY and AGENCY to continue to be bound by all terms and conditions of the Agreement, all of which are expressly incorporated into this Amendment by this reference, except as expressly changed by this Amendment.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties hereto agree as follows.

1. Section 3 of the Contract (Compensation/Price Ceiling) is hereby amended by the addition of WebKPF effective October 1, 2008. The additional cost per device is \$1.00.
2. Section 3 of the Contract (Compensation/Price Ceiling) is hereby amended by adjusting the total monthly fees for all locations from \$9,461 to \$9,546 effective October 1, 2008.
3. Section 3 of the Contract (Compensation/Price Ceiling) is hereby amended by adjusting the total contract amount from \$113,532 (\$9,461 x 12 months) to \$114,297 [(\$9,461 x 3 months) + (\$9,546 x 9)].
