- 2. In addition to the variation allowed above, per Section 3.06 of the Agreement, any amount not expended for mileage/training/travel may be utilized for other services authorized by this Agreement (i.e. Personnel).
- 3. Relevant training and associated travel expenses must be approved in advance by the MHD.
- 4. Mileage rate as set by IRS, except for vehicle purchased by El Dorado County which will be reimbursed at \$.27 per mile.
- 5. Every effort should be made to use the El Dorado County purchased vehicle for work performed under this agreement.
- 6. In no event shall County be obligated to pay Contractor for any amount above the Total Not-to-Exceed for this Agreement, as shown above.
