2022 PROPOSED SOLID WASTE COLLECTION AND MATERIAL RECOVERY FACILITY RATE INCREASES

Notice is hereby given that a public hearing will be held via Zoom at 10:00 a.m. on Tuesday, June 21st, 2022, by the El Dorado County Board of Supervisors which will be held at the Board of Supervisors' Chambers, 330 Fair Lane, Building A, Placerville, California. The public hearing will consider the request by El Dorado Disposal Service to increase solid waste collection rates by 4.07 % for Franchise Areas A, B, and C, as well as the Material Recovery Facility, to be effective July 1, 2022.
