General: The El Dorado County Procurement & Contracts Division is requesting bids for the purchase of Three (3) New 2025 Nissan Altima SV AWD Sedans. This bid is a **"brand specific"** bid. Bidders must quote the Nissan Altima. Alternate brands will not be accepted.

Vehicle and equipment offered in response to this bid shall be in compliance with all provisions of the California Vehicle Code, State of California Division of Industrial Safety, and Federal Motor Vehicle Safety Standards.

Bid pricing shall be inclusive of factory rebates and incentives, dealer charges including dealer preparation, delivery & DMV processing and fees (The County is exempt from DMV vehicle license fees). Applicable tire fee will be added to the purchase order; bidders shall **not** include this fee on the bid Quotation Schedules.

Bid Preparation / Submittal Checklist

- [] All required bidder information on Page one (1) of the Invitation to Bid is completed and has the original signature of an authorized agent.
- [] Note that erasures, overwrites, and the use of correction tape/fluid are NOT acceptable. Refer to Item #3 of the General Terms and Conditions for specific instructions.
- [] Any vehicles bid on the Quotation Schedule are bid 100% complete, including "Yes" / "No" (Y/N) check marks and exceptions to defined specifications.
- [] Note any prompt payment discounts available on the Prompt Payment Discount Terms, Page thirteen (13).
- [] Indicate delivery lead times on the Quotation Schedule, Page twelve (12).
- [] A valid California Seller's Permit number is entered on Page six (6).
- [] All requirements of this Invitation to Bid have been met.
- [] Local Vendor Preference Affidavit of Eligibility if applicable. Link to form information available on Page eight (8).

Specifications: Vehicle specifications are a general guideline. Minor deviations from these specifications may be accepted at the sole discretion of the County. Major exceptions, which, in the sole opinion of the County, affect the function of the vehicle, will not be accepted. Additional specifications are as follows:

1. Vehicle offered cannot require the use of premium or specialty fuel products.
2. A factory authorized service facility must be located within forty (40) miles of 2443 Headington Road, Placerville, CA 95667 (County's Fleet Services location) for the make of the vehicle bid.
3. Vehicle equipment not specified on the bid but included standard on the vehicle shall be included with the vehicle upon delivery at no additional charge.
4. Vehicle, wheels, and tires shall be able to accept snow tires or cable snow chains.

Requirements: Bidders failing to comply with any of the following requirements will not be considered for the evaluation and award process:

1. Vehicle must be available for immediate delivery after receipt of the County's order; factory orders will not be accepted.
2. Bidders are required to complete all line items for each vehicle offered in the Quotation Schedule regardless of any attachments.
3. Bidders must complete the "Yes" / "No" (Y/N) column with either "Y" indicating the vehicle specifications are exactly the same as the bid specifications or an "N" indicating that the bid vehicle specifications are not exactly the same. **Do not use checkmarks.**
4. **Bidders not responding with a "Y" or "N" may be rejected and not considered for evaluation and award.**
5. Any specifications marked with an "N" must also include the exact specification being bid that deviates from the County's bid specifications in the "Exceptions" column. **Failure to include this information may cause the bid to be rejected and not considered for evaluation and award.**
6. Bid price must remain in effect for a period of **no less than ninety (90) days** from the date of the bid opening.

California Sales & Use Tax Requirement: A California Seller's Permit is required to conduct business in California. Bidders must possess a valid and current California Seller's Permit at the time of bidding and maintain such permit in good standing throughout the awarded period. In order to proceed without a California Seller's Permit, such bidder must establish that the bidder falls under an exception to the seller permit requirements of the California Department of Tax and Fee Administration (CDTFA). Those requirements can be found at www.cdtfa.ca.gov.



Merchantability: There shall be an implied warranty of merchantability and fitness of an intended use. Any bid submittals taking exception to this requirement may, at the County's option, be considered non-responsive.

County's Rights: The Purchasing Agent reserves the right to not enter into any agreement, cancel this process at any time, amend this process at any time, or to award more than one contract to the lowest, responsive, responsible bidders if it is in the best interest of the County.

Returns: The County reserves the right to return product within thirty (30) days of receipt by the County for credit or refund without a shipping or restocking fee. Product returned shall be in good condition and in the original package (if applicable). Defective product or product under warranty may not always be returned in the original package.
