A. The good/service requested is restricted to one supplier for the reason stated below:

 Why is the acquisition restricted to this goods/services supplier? (Explain why the acquisition cannot be competitively sourced. Explain how the supplier is the only source for the acquisition.)

Nevada County is the current contractor of After Hours Telephone Crisis Line Services which is a mandated service per Department of Health Care Services. The El Dorado County Health and Human Services Agency (HHSA) Behavioral Health Division is mandated to provide a crisis line for the Adult system of Care (ASOC) and Children's System of Care (CSOC) for mental health referrals or children, youth, and adults as well as telephone answering services for CSOC child welfare calls. HHSA has been contracting with Nevada County for these service since 2019 as they have specialty skills, qualifications and equipment required to provide Crisis Line and Access Line services. Expanding to twenty-four hour (24) hour, seven (7) day a week coverage with Nevada County will allow for the public to more easily access behavioral health services including the Mobile Crisis Team and other County Mental Health services.

This agreement is exempt from "competitive bidding under C-17 3.4(3), Exemptions from Competitive Bidding as "competitive bidding would produce no economic benefit to the County."

2. Provide the background of events leading to this acquisition.

Effective January 1, 2025, El Dorado County launched the Mobile Crisis Team countywide. This expansion has led to an increased demand for both Crisis Line and Access Line services. While the County currently provides these services from 8:00 a.m. to midnight, the growing need, along with staffing considerations, necessitates an expansion of services through Nevada County.

3. Describe the uniqueness of the acquisition. (Why was the goods/services supplier chosen?)

This provider was chosen because they have been providing the After Hours Telephone Crisis Line Services to El Dorado County since 2019.

4. What are the consequences of not purchasing the goods/services or contracting with the proposed supplier?

The consequences of not purchasing the services or contracting with Nevada County would be the continued use of El Dorado County staff and increased expense to the County through on-call and overtime expenses for covering the Crisis Line and Access Line services.
