A. The good/service requested is restricted to one supplier for the reason stated below:

1. Why is the acquisition restricted to this goods/services supplier? (Explain why the acquisition cannot be competitively bid. Explain if this is an emergency purchase or how the supplier is the only source for the acquisition.)

Closure is a sole source provider of a specialized Digital Analyst for investigations and prosecutions that consolidates multiple analytical functions—semantic (concept) search across modalities, large-scale audio intelligence (transcription/translation/search with prosecutorial auditability), and warrant-return ingestion/analysis, within a single user interface and workflow set. According to Closure's survey of the field, other offerings are "point solutions" limited to a single task (e.g., transcription engines, document review tools, CDR visualizers, redaction tools, timeline builders) or systems integrators that connect systems but do not deliver this integrated analytical suite for prosecutors. To the best knowledge of Closure management (as of Sept. 2025), no other vendor offers all of these functions for law enforcement/prosecution in one platform.

2. Provide the background of events leading to this acquisition.

Investigative and prosecutorial teams routinely need to integrate, organize, and interrogate large volumes of evidence across many formats and source systems. Closure's Digital Analyst was designed specifically for those demands, promising to accelerate investigations and prosecutions, reducing manual review, and enabling rigorous exploration of alternative/exculpatory hypotheses. Based on Closure's documented capabilities and market scan, the department seeks to procure this single solution rather than assemble and operate multiple point tools.

3. Describe the uniqueness of the acquisition. (Why was the goods/services supplier chosen?)

As of Sept. 2025, Closure's analysis has concluded that there are many other analytics vendors with "point solutions" pertaining to specific types of evidence or specific workflows — these include transcription engines, document review platforms, case management tools, device imaging and extraction companies, call detail record visualizers, video analysis tools, redacting products, timeline builders, and much else. Separately, there are system integrators, who primarily focus on integrating multiple source systems for other functionality. However, these point solutions and system integrators fall short of Closure's robust approach across analytical tasks within an investigation & prosecution. Unique capabilities include: Semantic Search across media: concept-based search over thousands of pages and mixed media (documents, images, audio, other files) rather than simple keyword matching; Single interface/workflow: an integrated suite expressly engineered for investigators and prosecutors, not a general analytics product; among other unique capabilties.

4. What are the consequences of not purchasing the goods/services or contracting with the proposed supplier?

The unified capability is what enables Closure to expedite the identification and analysis of specific, citable textual passages, images, utterances, and more, critical to investigations. Absent this purchase, staff would remain dependent on multiple disconnected point solutions and manual review, limiting the ability to perform concept-level search across modalities with fragmentation that slows investigations and prosecutions.

As of Sept. 2025, our analysis has concluded that there are many other analytics vendors with "point solutions" pertaining to specific types of evidence or specific workflows — these include transcription engines, document review platforms, case management tools, device imaging and extraction companies, call detail record visualizers, video analysis tools, redacting products, timeline builders, and much else.
