

AGREEMENT FOR SERVICES #188-S1410  
AMENDMENT III

This Amendment III to that Agreement for Services #188-S1410, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Trainers, Inc. (dba Custom Training), a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 5580 La Jolla Blvd., #411, La Jolla, CA 92037; (hereinafter referred to as "Contractor");

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide training classes, training materials, and books to employees of the Probation Department on an "as-requested" basis, in accordance with Agreement for Services #188-S1410, dated September 04, 2013, Amendment I, dated November 23, 2013, and Amendment II dated January 21, 2015, incorporated herein and made by reference a part hereof; and

**WHEREAS** the parties hereto have mutually agreed to increase the overall Agreement total by \$56,644.00 for a shall not exceed amount of \$120,000.00, hereby amending **Article III, Compensation for Services**; and

**WHEREAS**, the parties hereto have mutually agreed to amend **Article III, Compensation for Services**; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #188-S1410 shall be amended a third time as follows:

**ARTICLE III**

**Compensation for Services:** For services provided herein, County agrees to pay Contractor monthly in arrears and within forty five (45) days following the County's receipt and approval of itemized invoice(s) identifying services rendered. For the purposes of this Agreement, the billing rate for tuition shall not exceed the STC approved tuition rate of \$100.00 per student per class (a minimum of 16 students per class). Classes provided for the Probation Department may also require, on an as-needed basis, the purchase of training materials, books, and/or certification cards which shall be itemized and invoiced separately from tuition charges for STC Certified Classes.

The total amount of this agreement for all services and materials, including the purchase of training materials, books and /or certification cards, shall not exceed \$120,000.00.


Except as herein amended, all other parts and sections of that Agreement #188-S1410 shall remain unchanged and in full force and effect.
