All,

I would like to request that you pull this item from the consent calendar. An item where you are proposing an ordinance which didn't get a unanimous vote on the first reading should not be on consent. It should be a general business agenda item and there should be a full public discussion on it even if the vote is apparently a done deal.

I would also like to address some of the things that were said during the March 14th meeting and some other things.

First, it was stated that the commission had no conservative commissioners. The district two commissioner is an active member of the Republican Party.

It was stated that the board does care about human rights. I don't doubt that you do, but what message does eliminating this commission without first devising an alternative send to the rest of the state, country and world?

One person complained that there was opposition to her appointment because she's conservative. Let me correct the record. There was opposition because she doesn't play well with others. The fact is that the person who ended up getting the appointment is conservative. So much for that.

Another person complained that her complaint wasn't heard by the commission. Where in the ordinance or in the bylaws does it state that the commission is about hearing personal grievances? Wasn't that removed from the ordinance in 2020? "To inquire into incidents of tension and conflict among or between people..."

The commission is too political? How? What examples do you have, and how have you tried to correct that?

The commission is out of control? How can a commission with two county supervisors on it be out of control?

The Oak Ridge incident butted into school district business and tried to direct? I was there. This meeting was held to talk about an incident of great concern to the county and to find out what actions the school and the district were taking. It was educational as per the commission's guidelines.

The board says the commission stepped out of bounds on multiple occasions. What action did the board actually take to correct this? The board has the discretion to remove commissioners and appoint new ones. Surely if the commission was doing the wrong thing and had been given direction and still did not change, the board could have done this. Why wasn't this done?

This is the board's responsibility. Seriously? I've heard complaints made to the board during open forum from Melody Lane, Mandi Rodriguez, Joseph Connelly, Eric Nelson and others, but I have never heard the board address any of them (yes, I know, Brown act). How exactly is the board going to take on human rights issues then? You can't just allow them to talk on open forum. There has to be a mechanism. You don't have a concrete plan. You are eliminating this commission, and then talking about looking around at what you might do. Are you committed to making those things happen (other than adding a paragraph to the board handbook we don't even know what those things are) once this commission has been eliminated?

The homeless forum that the commission put together last year was very well done. Only the two supervisors who were on the commission were there. The forum put a human face on homelessness, and I believe actually got help right afterwards for a homeless veteran who had been injured on the job, and who hadn't been treated right by the worker's compensation system. It raised awareness that likely helped you make our new Navigation Center happen.

There are so many things this commission could take on in addition to civil rights abuses. The residents of Grizzly Flats were not treated fairly by the Federal Government. They need help. The commission could have taken this on.

There is domestic abuse in our county, (by both men and women, incidentally). They could have shone a light on this issue that affects families and children.

The could have taken on human trafficking, false accusations and convictions, food insecurity, the shortage of well-paying jobs and affordable housing, insurance being unaffordable due to the high fire danger, flooding issues, unavailability of affordable broadband in our rural areas, power outages especially affecting the elderly, lack of services for people with disabilities, addiction, etc. etc., and now all of that is on hold until who knows when.

I don't accuse any of you of not caring (you didn't get into public service because you don't care), but I am very, very disappointed.

Dear Members of the El Dorado County Board of Supervisors,

We need a Human Rights Commission.

I understand members of the board who served on the commission expressed concerns regarding the efficiency of the current commission and concerns over actions commission members made stretching the parameters of their duties. If indeed the case, rather than disbanding the commission we need to strengthen the skills of the members serving, educate members of their duties, or replace the members of the commission. These actions would serve the people of El Dorado County far better rather than dissolving the commission altogether.

If meetings are less efficient, if members' actions created extra work for supervisors, the county needs to provide a clear job description for the members serving on the commission defining their scope of duties and the process of procedures for action.

To disband the human rights commission during this time of civil dissonance would encourage negative behavior and attitudes toward community members who are seen as different. Further, the elimination of a Human Rights Commission instills fear and suppression of those in our community whose voices are minimized by the loud and self-serving. A county supporting a Human Rights Commission is a county encouraging voices to be raised in an appropriate venue guided with procedure and an expectation for all involved to listen with respect to all invested.

If the Board of Supervisors decides the members of the commission are beyond educational training or the members demonstrate an inability to open-mindedly receive needed support the county wishes to provide them, intervention may be unrealistic. However, to disband the Human Rights Commission without first establishing an alternative agency, eliminates the ears of an agency needed to hear the abuses, perceived and real, of the concerned. Before dismantling the commission, an alternative must be in place.

If the current Human Rights Commission is in need of its members to receive training and support, provide training and support; if the membership suffers from dysfunction or inability to work together, replace the members; if the commission need be replaced with an alternative agency, establish the agency first before termination of the current commission, but do not abandon our citizens of their need for a Human Rights Commission or advocacy in El Dorado County.

Dear Supervisors: I was unable to attend your meeting last week, wherein the majority continued its efforts to disband the Human Rights Commission without any evidence to do so. In watching the video of the meeting it was appalling to see Supervisor Turnboo propose that a civil rights coordinator position responsible for ensuring social services recipients receive benefits without discrimination would be a suitable replacement for a human relations commission for all residents of El Dorado County.

That proposal, and discussion of it, demonstrates clearly and consistently that the majority has no understanding or awareness of Government Code sections 50260-50265, and how to support the Human Rights Commission to fulfill its legal responsibilities and obligations. It also demonstrates how profoundly separate the Board is from its governing principles, that such a proposal could be made without any advance notice or evidence on the record to support it. The Board's failure to abide by its own governing principles, and the Board's senior advisors failure to responsibly intervene or correct blatantly misleading proposals, is a loud and clear signal that the majority cannot responsibly govern, nor that the current Board Chair has any interest in doing so with respect to the Human Rights Commission.

The majority decisions in this matter have been wholly unsupported by any evidence, irrational, and self-serving - all at the expense of the Board's integrity and the County's goodwill.

I am unable to attend tomorrow's meeting on this matter, but am completing a second formal complaint of the majority's rushed effort to disband an important right that all El Dorado County citizens have—the right to an effective and capable Human Rights Commission to carry out a "principal governmental concern and responsibility" in place since 1961. (Govt. Code, section 50261.) My draft complaint is attached for your consideration of the matter on March 21st.

I. BOARD DISCUSSION - MARCH 14, 2023

Supervisor Wendy Thomas, Board Chair, opened the item by describing it as "pretty self-explanatory," and asked if there were "any Board comments at this point?"

Supervisor Thomas did not acknowledge the originating matter of January 3, 2023, Board item 22-2067, which was to discuss and fill Board appointments "to various Boards, Commissions or Committees for 2023."

Nor did Supervisor Thomas acknowledge that the returned Board item 23-0128 of January 24, 2023 was *not* what the Board directed to be returned when it voted to return item 22-2067 for further discussion of an unfilled Supervisor vacancy to the Human Rights Commission ("Commission").²

A. SUPERVISOR HIDAHL'S SUPPORT FOR THE COMMISSION

Supervisor Hidahl remarked, "I feel deep in my heart there's a need to continue something in the area of human rights. ... It doesn't appear [Bridging Divides El Dorado] is a viable potential. ... I would be pleased to entertain a discussion of alternative paths if we do think there is something here."

"I do think the [commission] serves a very valuable purpose. If we were to be inclined to restructure it, reformat it, I think we could make sure that the expectations of the Board were met, but at this point in time, I would hope we find a way to continue something in this area because I think it's absolutely necessary in our communities. There's been a long history of things that we need to be able to understand why people feel the way they do, and hopefully over time, be able to influence and change that."

"I think [the commission] has a valid purpose. I'd like to see it continue and how that happens is to be determined."

B. SUPERVISOR LAINE'S SUPPORT FOR THE COMMISSION

Supervisor Laine reaffirmed her commitment to fulfilling the Board's *mandatory* appointment of two Supervisors to the commission.³

"...I did volunteer to serve on this commission at our last meeting in which a discussion around the Human Rights Commission took place and I still stand by that position."

C.

SUPERVISOR TURNBOO'S UNFOUNDED ARGUMENTS AGAINST THE COMMISSION

Supervisor Turnboo repeated the majority's reliance on making unfounded statements, without any factual evidence to support them, as a basis for disbanding the commission.

He started with an informal fallacy argument, akin to a "straw man," or "hollow man" view; e.g., "...you gotta understand there's only nine counties that adopted this-Human Rights Commission through the state of California."

MISLEADING COMPARISON TO CIVIL RIGHTS COORDINATORS FOR SOCIAL SERVICES RECIPIENTS

Supervisor Turnboo then explained that he looked at different alternatives, "and Shasta County ... has a civil rights coordinator up there. They don't have a Human Rights Commission; they have a coordinator."

Without entering any evidence into the item record, Supervisor Turnboo proceeded to read information about Shasta County's "coordinator" in an attempt to mislead the public about the responsibilities and obligations of the commission under Government Code, sections 50260-50265.

Supervisor Turnboo failed to mention that the California Department of Social Services has a "Civil Rights Unit" to "ensure[] effective access and nondiscrimination

to all applicants and/or recipients of benefits and services provided by the Department and county welfare departments. Activities include discrimination complaint investigations, county compliance monitoring, technical assistance, training, and ongoing monitoring for state and federal regulatory compliance."⁵

Supervisor Turnboo also failed to mention that the El Dorado County's Health and Human Services' civil rights coordinator for *HHSA benefits and services* is listed online, along with all other County civil rights coordinators. (See Figure 1.)⁶

Without *any apparent knowledge* of what a County Civil Rights Coordinator is, or does, Supervisor Turnboo promoted his example *from Shasta County* as a substitute for an authorized Human Relations Commission under Government Code, sections 50260-50265, saying, "And I think this is the better way to go."

"THIS COMMISSION HAS GOTTEN WAY TOO POLITICAL"

After describing his family history of having "half-breed" Indian lineage, and his view of its negative effect on that personal history, Supervisor Turnboo segued to say, "I think this particular human rights commission has gotten way too political. I think there's a problem there. And I think it should have been addressed a long time ago, and it wasn't."

"And I think the best way to solve this, I think we need to look at different alternatives to resolve this problem, and I think Shasta's doing the right thing with the civil rights coordinator." (bold, italics font added.)

Supervisor Turnboo did not describe any details of his complaints, nor place any evidence into the record to support them. Nor did he describe any "different alternatives" in any detail or with any evidence, other than his passing reference to an irrelevant comparison from Shasta County.

The local Mountain Democrat newspaper repeated Supervisor Turnboo's "Shasta" idea without any clarification that a social services civil rights coordinator is not a County wide human rights commission vested with mandatory legal responsibilities and obligations under Government Code sections 50260-50265.

"District 2 Supervisor George Turnboo referenced Shasta County's Health and Human Services Agency civil rights coordinator and its procedures of reporting alleged discrimination as an alternative method of supporting human rights in the county.

"I think this particular human rights commission has gotten way too political," Turnboo said. "I think there is a problem there ... it should have been addressed a long time ago and it wasn't. I think the best way to solve this is to look at different alternatives and I think Shasta has done the right thing with the civil rights coordinator." "7

Neither Supervisors Parlin or Thomas made any additional comments before opening the matter to public comment.

II. POST PUBLIC COMMENT BOARD DISCUSSION

Following extensive public comment, Supervisor Thomas invited other Supervisors to make any additional comments.

.

SUPERVISOR HIDAHL'S FOCUS ON LAW ENFORCEMENT AND THE "SHASTA COUNTY" PROPOSAL

Supervisor Hidahl began with saying, "So, after listening to public comment I'm even more concerned with the cancellation of this human rights commission. *Something* needs to continue." (bold, italic font added.)

Instead of acknowledging the law governing a California human relations commission, and the financial and staffing resources available to fully support a commission under that law, Supervisor Hidahl latched on to Supervisor Turnboo's "Shasta County" proposal as a potentially viable solution, before expanding his comments to include his view of the necessity for the El Dorado County Sheriff's Department and District Attorney's involvement in human rights matters.8

"I do like the idea that Supervisor Turnboo brought forward that there is other solutions here. And it was brought up that maybe it's a combination of things, and so what I would like to see is a continuation that would allow us to have a better dialogue with the Human Rights commissioners and the approaches that Supervisor Turnboo has talked about, because when I hear what he's read off is that role, my first question is how does that interact with the Sheriff's Department? Because our law enforcement is a key part of how we deal with the illegal activities related to human rights, as is our District Attorney, etc."

"I'd like to understand it better, how Shasta County works that. If the person is not a member of the Sheriff's Department, how do they get the information they need to be able to make judgments, decisions, recommendations, whatever it is that's going on?"

⁸ Government Code, section 50263 reads, "The governing body may assign personnel to the commission or permit the commission to employ an executive director, a secretary, and such attorneys, experts and other employees as may be necessary, within the amount made available by the local governing body and to accept and expend funds from private, as well as public, sources. Each city and county is hereby authorized and empowered to make such appropriation for such expenses and for the compensation, if any, to be paid to the members of the commission." (bold font added.)

"Because I think that would considerably help the 'educate' part if we had somebody gathering that information and looking at what are the key issues we have at this point in time? How do we direct our education towards that process? So I do see the opportunity for kind of a dual role here at some point, but I want to look into it a little more."

"It's just not enough time to understand it, *hearing it just today*, but again, our law enforcement has to be a key aspect of what we look at relative to human rights and violations and claims and I just don't know how that integrates right now. I don't have a good sense of all the things that are being reported that are being properly addressed." (bold, italics font added.)

"And I think that's what this role is in Shasta County, it sounds like, but how do they get that information, because our Human Rights Commission has asked for information from the Sheriff's Department and the District Attorney as I understand it, and it's never been available because that is confidential information...."

1. A VACUUM OF RELEVANT INFORMATION

Supervisor Turnboo's proposal to substitute a limited civil rights enforcement role for recipients of social services benefits, in lieu of a human relations commission with mandatory responsibilities and obligations, shows a profound ignorance of the applicable law and its application, and a profound failure of the Board's system "to making decisions based on quality information, evidence and data."

For example, a human relations commission's mandatory responsibilities and obligations do not specify taking law enforcement or legal action to enforce violations of human rights. (See Gov't Code, §§ 50264-50265.)

However, the commission is mandatorily obligated to "issue any publications and reports of investigation as in its judgment will tend to effectuate the purposes of this article", "encourage and stimulate agencies under the jurisdiction of the local governing body that created the commission to take any action as will fulfill the purposes of this article", and "[t]o submit an annual report to the governing body." (*Id.*, §§ 50265, subds. (b), (d)-(e).)

Dear El Dorado County Board of Supervisors,

Once again, I would like to voice my support for the continued existence of our county's Human Rights Commission. Disbanding the Human Rights Commission, especially without allowing for dialogue between the commissioners and the Board, broadcasts a very public message that human rights and the health and well-being of our county's citizens and visitors are not a priority for this Board.

In her March 13th comments, Supervisor Thomas asked her audience *not* to assume that the board doesn't care about human rights. While I want with all my heart to believe that what she says is true, the actions of the Board speak otherwise.

During the Board meeting, Supervisor Thomas read from the March 7, 2017 Civility Resolution that the Board passed and adopted. The resolution concluded with:

be it further resolved that the El Dorado County Board of Supervisors will actively engage and pursue mechanisms to improve understanding, dialogue, and tolerance within our county and communities.

Supervisor Thomas underscored that the Civility Resolution was an *active* resolution. If this were true, the Board would, in fact, choose to preserve the Human Rights Commission as the commission's by-laws declare it to be a *mechanism to improve understanding, dialogue, and tolerance within our county and communities*. Moreover, the Board has refused to *actively engage* in dialogue with the Human Rights Commission about its decision to terminate the group. The Board's refusal to dialogue with commissioners is beyond disrespectful; not only is it unfair but it also violates the due process right established by the Fourteenth Amendment. Ironically, the Board's active resistance to engaging in dialogue with the Human Rights Commission highlights the very need for the commission in the first place. This refusal to allow the commissioners the opportunity to redress the accusations leveled against them goes against the Civility Resolution that Supervisor Thomas so earnestly purports to believe in. If the Board cannot even uphold the basic procedural right of due process, then how can community members truly expect the Board to uphold their human rights without a Human Rights Commission in place?

Supervisor Hidahl pointed out last Tuesday that BOS advisory groups are the Board's arms and legs. They are the grassroots letting the Board know what's going on in their constituent communities. As Hidahl stated, the Board can't be everywhere, nor can they hear everything on their own. They rely upon grassroots community organizations and networks to provide recommendations "on what [the Board] can do to change the environment we are in." The HRC's purpose is to listen to community members who've been on the receiving end of hateful and unjust acts, to educate communities about human rights, and to keep the Board abreast of abuses and discrimination occurring within their communities. The commission is meant to be a welcoming, safe sounding board for vulnerable people and groups to express

their piece. Without a Human Rights Commission in place to hear these folks out, where can they go, realistically, with their concerns? People whose human rights have been violated often don't have the freedom to appear on their own in front of the Board of Supervisors, nor do they necessarily have the desire to do so as it could set them up for further targeting. The Human Rights Commission is a vital and necessary clearinghouse for vulnerable populations in our county. As such, it should continue on with its good work.

I will end this letter by asking the Board of Supervisors to please walk their talk and postpone their final vote for two months, enabling supervisors to engage in open, productive dialogue with the Human Rights Commissioners, whereby all parties can address expectations, missteps, and successes of the commission. Such a conversation would, at the very least, allow the commissioners to exercise their right to due process.

I am writing today to urge that the Board reconsider its apparent determination to abolish the Human Rights Commission. It should be noted that I am writing both as a resident/voter in the county, but also as a leader of Sierra Forward (www.SierraForward.com).

I have stated our position publicly before. And I stated it privately in a meeting with Supervisor Thomas last Friday. It is clear from the Board's reaction generally, and Ms. Thomas's response specifically, that I might as well been whistling into one of the atmospheric river winds we have ben enduring of late.

My arguments have had no effect whatsoever. More telling is the fact that the scores of people who have weighed in on behalf of saving the commission---versus very few on the opposing side—have add the same effect, zilch.

But we are making one last try.

My first boss, essential mentor and close friend in the political realm was the late Norman Y. Mineta (Mayor of San Jose, Member of Congress, and Cabinet Secretary to two Presidents—one a Democrat and one a Republican).

As a ten-year-old boy in 1942, Norm and his family were expelled from their home in San Jose at gunpoint and sent to a "relocation camp" in Wyoming. They were among the 120,000 Americans of Japanese ancestry so treated. Their constitutional rights were abridged wholesale and completely. This shameful episode will forever tarnish the history of our great country (as will other historic

sins—slavery, Jim Crow, the extermination of millions of Native Americans, vigilantism aimed at migrants among them)

Norm would constantly remind those privileged to work for him that he, his family and other Japanese Americans were treated the way they were because of two things: 1) How they looked; and, 2) there was no one in an official capacity, and no agency, to which they could turn for help or advocacy.

That's a good reminder, it seems to me, as the Board pursues its ill-considered action vis-à-vis the Human Rights Commission. Think what happened to Norm Mineta couldn't happen again? Think again. Pay attention what's happening in our county right now.

Perhaps you will benefit from reading the quote from Reverend Martin Niemoller, who said about Nazi Germany (where he lived, preached, and was eventually imprisoned),

"First, they came for the socialists, and I did not speak out—because I was not a socialist.

"Then they came for the trade unionists, and I did not speak out—because I was not a trade unionist.

"Then they came for the Jews, and I did not speak out—because I was not a Jew.

"Then they came for me—and there was no one left to speak for me."

The Dissolution of the Human Rights Commission for El Dorado County

Dear Supervisors:

I have written to Supervisor John Hidahl previously regarding my support for the existing Human Rights Commission in El Dorado County. I want to reiterate my support at this time.

Your impending action to dissolve and abandon the Human Rights Commission on your Consent Agenda this Tuesday, March 21, is unwise. The timing is so bad, and the optics are terrible. You have received numerous pieces of correspondence by email and post, as well as public statements in your meetings, in support of the Human Rights Commission, but you have not provided a Public Forum for discussion of this action item with opportunity for full give and take discussion.

Your action to disband and discard the Human Rights Commission has been covered by The Sacramento Bee, The Tahoe Daily Tribune, and the Mountain Democrat newspapers, leaving the impression that El Dorado County at the highest governance level does not care about human rights. The individual supervisors have stated otherwise, but actions speak louder than words! Your proposed action to dissolve and abandon the Commission is like a bold headline for the community of supporters saying: "WE DON'T CARE WHAT YOU THINK".

You as a Board do not have the time or the inclination to listen to the many people who have complaints about human rights problems in this county, because you have so many other governance obligations, or so some of you have stated. Individuals who want to voice their concerns do not want to bring their many small grievances to the supervisors because they fear that their complaints will seem petty. However, problems pile up, and these individuals could benefit by using the Human Rights Commission and individual commissioners to air their grievances and resolve some of them. The Human Rights Commission is a great sounding board that allows problems to be aired and dealt with at a lower level of intervention than the Sheriff's Department,

the Mental Health Department, the Social Services Department, or the judicial system. The Commissioners role as educators is valuable. The cost has been negligible.

I have already told my supervisor of incidents in El Dorado Hills that warranted the attention of the Human Rights Commission. I recently heard that an activity group in a nearby community is chaired by a man who told members the reason he moved to El Dorado County is because it is "so white"! This kind of thinking is problematic on so many levels. I am embarrassed for my friends and neighbors who have to deal with people like that, and I do my best to exhibit the opposite kind of behavior. I appreciate the problems that the Human Rights Commission is dealing with because they are real, they are important, and they are personal.

I used to live in Peoria, Illinois, many years ago. It was common knowledge that a black man or woman should not venture or remain at night across the river in Pekin, Illinois, for any reason as it was too dangerous. That is the reputation that Placerville and parts of El Dorado County are getting, and that is so unfortunate. We need to work on issues like this, and the Human Rights Commission is an appropriate forum for these kinds of discussions.

Please pull Item 23-0283 from the Consent Agenda and table it for future discussion at an appropriate forum. It will be to your credit and greatly appreciated by those who support the Human Rights Commission.

Dear Board of Supervisors,

I am highly troubled by your vote last week to dissolve the Human Rights Commission despite the overwhelming public support not to do so. There was very little support to dissolve the commission as seen in the vast amount of recorded letters and public testimony during the BOS meeting of 3/14/2023.

In addition, the last HRC report given to the BOS was on 11/8/22 and can be seen below

During this meeting commissioners Simpkin and Carr gave the BOS a report of commission activity. Ms Carr gave a report on the El Dorado County Homeless Forum and her report was met with praise from all the BOS members. It must be noted that Supervisor Turnboo specifically stated that he really appreciated what Ms. Carr is doing for the district and county and the homeless population and how well she is representing him and his district as a human rights commissioner. There was no mention by anyone that the BOS was planning or considering to dissolve the commission in the near future. There was a concern raised by Ms Parlin regarding the speaker series potential speakers however she quickly deferred to the sitting supervisors on the commission. The next communication the HRC had with the BOS was when the HRC was notified of its dissolution.

I am a commissioner and never once had any opportunity to appear before the BOS aside from offering public comment as a private citizen and that was 3 minutes with no discourse. The HRC was bushwhacked and paralyzed before any procedural and statutory vote took place to dissolve the HRC. The HRC was slandered with unfounded accusations lacking in merit during the BOS meetings that followed. My only opportunity to face my accusers was in the public comment space during the BOS meetings and I was not afforded any statutory or regulatory opportunities to protect and safeguard myself against the slander, defamation and misrepresentation thrust upon me. I have acted in good faith and good will commensurate with my education and long career as a mental health practitioner and community worker who is expected and governed by law to do no harm and maintain health equity among all peoples who suffer discrimination and marginalization.

I have asked over and over for a list of specific accusations or charges against me. I have never received such. I believe I have a civil right to face my accusers, in removal of my post, whose accusations cause professional harm and violate their very own governance structure.

It has been noted by Supervisor Laine as a new member of the BOS, that she has noticed the BOS exhibit a pattern of abolishing and eliminating commissioners, commissions or advisors that they do not agree with. This includes eliminating the requirement for Implicit Bias Training after two or three commissioners (out of 150 commissioners or so) left their posts in part due to the required Implicit Bias Training. I agree with Supervisor Laine and I am the newest member of the HRC.

In the motion to dissolve the HRC, **Supervisors Thomas, Laine and Parlin** are the responsible supervisors doing such without having had any discussion, conversation or discourse with the commissioners regarding

9. 23-0283 Clerk of the Board, based on direction provided the Board of Supervisors, recommending the Board Approve the Final Passage (Second Reading) of Ordinance 5175 amending Title 2, Article XIV, Section 2.20.110 (et.seq.), dissolving the El Dorado County Human Rights Commission. (Cont. 3/14/2023, Item 17).

The HRC commissioners never took political action and in fact never made any recommendations or suggestions for an ordinance or statute/ governance modification to the BOS at all. To date, the BOS has never stated what specific actions the HRC was being accused of.

The BOS has acted in negligence pertaining to governance and altered county ordinance code along with county infrastructure to harm the safety, protection, and well-being of our residents, businesses and visitors who lose the social protections of required Implicit Bias Training and access to the El Dorado County Human Rights Commission whose mission is to foster peaceful relations in the interest of preserving the public peace among residents of different races, religions, national origins, and the other characteristics listed in Government Code section 11135.

Where do you expect our residents of different races, religions, national origins, and the other characteristics to seek county support in a safe space dedicated to the protection of human rights?

This action is very irresponsible and bigoted Ms Thomas, Ms Parlin and Mr Turnboo. Please do not dissolve this commission.

You have heard the voices of victims of racism, poverty, homelessness, marginalization, drug addiction, domestic violence and you choose to remove them from the conversation or participating in civic discourse by shutting down their portal to belonging.

You are now refusing victims such as LGBT or domestic Caldor fire refugees in EDC without clean water to have a commission to represent them and listen to them. This is all recorded in your BOS minutes, archived video of the homeless forum, and in the many letters sent to you.

Please reverse your decision to dissolve the human rights commission and respect the marginalized people you serve.

I also lost faith in your leadership through this attempted action. I do see Ms Parlin as the ringleader in abolishing the HRC and implicit bias training. In my opinion she is a dangerous leader. I have witnessed Ms Parlin walk out of a meeting in which she did not get the appointment to an ad hoc economic development committee that she believed she and Ms Thomas were entitled to.
