OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO  
**IN RECOGNITION OF HARRY J. NORRIS**  
FOR HIS MANY YEARS OF DEDICATED SERVICE  
TO THE CITIZENS OF EL DORADO COUNTY

**WHEREAS**, Harry J. Norris has provided distinguished service to the County of El Dorado and its citizens serving two terms as Director on El Dorado Irrigation District Board and as a Member of the El Dorado County Board of Education; and

**WHEREAS**, while serving on the EID Board of Directors, Harry was also a Commissioner representing special districts on the El Dorado County Local Agency Formation Commission and a member of the El Dorado Water and Power Authority Board of Directors; and

**WHEREAS**, for ten years prior to beginning his service on the EID Board, Harry served on the El Dorado County Board of Education, receiving that agency's 1999 Leader in Boardmanship and its 2003 Spirit of Boardmanship awards; and

**WHEREAS**, Harry currently serves on the Marshall Medical Center Board of Directors; and

**WHEREAS**, for 25 years Harry operated a successful small business located in El Dorado Hills, and was a founding member of the El Dorado Hills Chamber of Commerce; and

**WHEREAS**, in 1990 the El Dorado Hills Chamber of Commerce recognized Harry's Union 76 business as Small Business of the Year; and in 1998 recognized him personally as Citizen of the Year; and

**WHEREAS**, from 1967-1970 Harry served with distinction in the United States Army, including service as a platoon leader with the 101st Airborne Division in combat in Vietnam, where in 1969 he was twice awarded the Bronze Star for heroism in combat;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of El Dorado the following:

- A. The Board gratefully acknowledges Harry's eight years of outstanding service to El Dorado Irrigation District and the public it serves.
- B. The Board commends Harry for his decade of public service with the El Dorado County Board of Education, and his ongoing public service with Marshall Medical Center's Board of Directors.
- C. The Board congratulates Harry for his twenty-five years of success and leadership as the owner of a small business.
- D. The Board thanks Harry for his heroic military service to this country.
