OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, a public hearing was held on December 2, 2014 for the purpose of adjusting solid waste collection rates within the Franchise Area of South Tahoe Refuse, American River Disposal Service.

WHEREAS, the South Tahoe Refuse, American River Disposal Service solid waste collection rates shall have a four percent (4%) increase effective January 1, 2015.

NOW, THEREFORE, be it resolved that effective January 1, 2015 the following rates are to be adjusted upward four percent (4%) for the collection of solid waste within the South Tahoe Refuse, American River Disposal Service Franchise Area:
