

RESOLUTION NO. 082-2025

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, California Business and Professions Code, Sections 12210, 12210.5 and 12240, authorize the Board of Supervisors of the County of El Dorado to adopt legal regulations to authorize the El Dorado County Agricultural Commissioner/Sealer of Weights and Measures to establish a schedule of fees not to exceed the costs incurred for the services provided; and

WHEREAS, Chapter 5.54 of the County Ordinance Code for Commercial Weighing and Measuring Instruments imposes an annual registration fee as set out in Business and Professions Code section 12240, and authorizes the Board of Supervisors to establish the amount of the fee by resolution; and

WHEREAS, pursuant to the California Food and Agricultural Code, Sections 11704, 11734, 11923, 12034, 12981, 15204, and Chapter 5.18 of the County Ordinance Code for pest control activities, the Board of Supervisors may establish reasonable registration fees for Agricultural and Pesticide Usage Programs specified in these sections; and

WHEREAS, California Food and Agricultural Code Division 17, Chapter 10.5, Article 3, Direct Marketing Certificates Section 47020 authorize counties to enact fees set by the County Agriculturual Commissioner to recover costs related to the certification and inspection of Certified Farmers' Markets and Certified Producers; and

WHEREAS, California Food and Agricultural Code, Division 12, Chapter 1, Article 4, Registration and Identification of Apiaries Section 29040 authorizes the Secretary of California Food and Agriculture to impose fees to cover the cost of apiary registration that is collected by the County; and

WHEREAS, Health and Safety Code, Section 25404, authorizes the Board of Supervisors to adopt a fee to recover costs of performing annual inventory of hazardous materials that are stored or handled on agricultural premises; and

WHEREAS, the fees in the attached schedule (Exhibit A) have been reviewed for statutory limits set forth in the code sections referenced above and all applicable limits have been incorporated into the fee schedule therein; and

NOW THEREFORE, BE IT RESOLVED, the Board of Supervisors hereby adopts the following attached schedule of fees (Exhibit A) for use by the El Dorado County Department of Agriculture, Weights and Measures; and

BE IT FURTHER RESOLVED, that the fees contained in the attached Fee Schedule (Exhibit A) shall be reviewed annually by the Department of Agriculture, Weights and Measures and revised in accordance with Board of Supervisors' Policy; and

BE IT FURTHER RESOLVED, that the El Dorado County Department of Agriculture, Weights and Measures Fees shall become effective July 01, 2025; and

BE IT FURTHER RESOLVED that this resolution will upon adoption by the Board of Supervisors; supersede Resolution Number 393-2006 and 022-2013.
