EQUIPMENT FLEET SUPERINTENDENT

DEFINITION

Under general direction, plans, organizes, oversees, coordinates, ~~schedules~~ and ~~directs~~ reviews the work of staff performing difficult and complex professional, technical, and administrative support related to fleet and equipment management and maintenance program programs for the Department of Transportation; performs automotive and construction equipment procurement maintenance, and repair ~~and operation~~; assists with long- and short-term project planning; oversees the operations of a wide variety of projects and other programs; coordinates assigned activities with other County departments and outside agencies; provides complex and responsible support to the Deputy Director of Maintenance and Operations and others in areas of expertise; and performs related duties as assigned.

DISTINGUISHING SUPERVISION RECEIVED AND EXERCISED

Receives general direction from the Deputy Director of Maintenance and Operations. Exercises general direction and supervision over supervisory, professional, technical, and administrative support staff through subordinate levels of supervision.

CLASS CHARACTERISTICS

~~This class, through subordinate supervisors, manages the day-to-day activities of both the west Slope (including Placerville) and the South Lake Tahoe Equipment Maintenance Shops. This class manages the entire Equipment Maintenance Program for the Department of Transportation.~~

This is a management classification. The incumbent is responsible for planning, organizing, reviewing, evaluating, and administering the day-to-day activities the County's maintenance shops and related Department of Transportation maintenance programs, as well as the County-wide fleet program which includes all vehicles and equipment owned and operated by the County. Responsibilities include developing and implementing policies and procedures for assigned programs, budget administration and reporting, and program evaluation. Incumbents serve as a professional-level resource for organizational, managerial, and operational analyses and studies. Performance of the work requires the use of considerable independence, initiative, and discretion within established guidelines.

Education and Experience:

Any combination of the required training and experience that would provide the required knowledge, skills, and abilities is qualifying.

Equivalent to graduation from high school, supplemented by coursework in vehicle and equipment repair and business administration including supervisory training;

AND

Five (5) years of progressively/increasingly responsible experience in the procurement, repair, and maintenance of fleet vehicles and road construction equipment, with three (3) years of supervisory experience at a level equivalent to the County's class of Equipment Maintenance Supervisor.

Note: ~~The above qualifications are a typically accepted way~~ Licenses and Certifications:

- Possession of a valid California or Nevada Driver's License and a satisfactory driving record.

PHYSICAL DEMANDS

Must possess ~~obtaining~~ mobility to work in the field and in a standard office setting and use standard office equipment, including a computer; and to operate a motor vehicle to visit various County facilities and meeting sites; vision to read printed materials and a computer screen; and hearing and speech to communicate in person, before groups, and over the telephone. Standing in and walking between work areas is frequently ~~required knowledge and skills~~; occasional field work which may require standing for long periods of time or extensive walking over uneven ground. Finger dexterity is needed to access, enter, and retrieve data using a computer keyboard or calculator and to operate standard office equipment. Positions in this classification bend, stoop, kneel, and climb to perform work and inspect work sites. Employees must possess the ability to lift, carry, push, and pull materials and objects weighing up to 50 pounds. Reasonable accommodations will be made for individuals on a case-by-case basis.

ENVIRONMENTAL CONDITIONS

Employees predominately work in an office environment with moderate noise levels, controlled temperature conditions, and no direct exposure to hazardous physical substances. Employees may work in the field and occasionally be exposed to loud noise levels, cold and hot temperatures, inclement weather conditions, road hazards, vibration, mechanical and/or electrical hazards, and hazardous chemical substances and fumes. Employees may interact with members of the public or with staff under emotionally stressful conditions while interpreting and enforcing departmental policies and procedures.

WORKING CONDITIONS

Must be willing to work evening, night, weekend, and holiday shifts as required.
