ORDINANCE NO. 5176

AN ORDINANCE AMENDING THE EL DORADO COUNTY ORDINANCE CODE Title 3 and Title 5 TO UPDATE THE TREASURER AND TAX COLLECTOR'S SCHEDULE OF

The County of El Dorado Board of Supervisors will hold a public hearing in the Board of Supervisors Meeting Room, 330 Fair Lane, Placerville, CA 95667 on June 27, 2023, at 3:00 p.m. to consider the introduction and final passage of Ordinance No. 5176 which are proposed amendments to the El Dorado County Ordinance Code (EDC Ordinance Code) Title 3, Revenue and Finance, and Title 5, Business Taxes, Licenses and Regulations, to update the Treasurer-Tax Collector's Schedule of Fees. The proposed amendments will add

fees to the Treasurer-Tax Collector's Fee Schedule in Section 3.29.040 and the Business License Fee Schedule in Section 5.04.030 of the EDC Ordinance Code to reflect the reasonable cost of providing the specified services, such as subscription fees for access to the El Dorado County FTP site, fee to separate current year secured. property tax bill or delinquent secured assessment, fee to calculate assessment for nonpayment of Transient Occupancy Tax (TOT), fees to provide duplicate copy of a TOT certificate and a business license, and fee for late business license
