- A 24 hours a day, seven days a week telephone hotline for crisis calls.
- Temporary housing and food facilities.
- Psychological support and peer counseling provided in accordance with Section 1037.1 of the Evidence Code.
- Referrals to existing services in the community.
- A drop-in center that operates during normal business hours to assist victims of domestic violence who have a need for support services.
- Arrangements for school age children to continue their education during their state at the domestic violence shelter-based program.
- Emergency transportation as feasible.

In accordance with Section 18295, to the extent possible, and in conjunction with already existing community services, the domestic violence shelter-based program shall also provide a method of obtaining medical care, legal assistance, psychological support and counseling, and information regarding other available social services.

<b>• Describe the social and economic characteristics of persons receiving services, by type of service provided:</b>	
<p>There were 651 individuals were provided domestic violence services. 68.1% were between the ages of 25-59. 1.1% were under 18. 2.8% were between the ages of 18-24. 8.8% were over 60 years of age. 46.6% identified as of Caucasian decent. 10.5% identified as Hispanic. 36.7% declined to state a racial identity. The remaining 6.2% of clients identified as Native American, African American, Pacific Islander, Asian, or Other. 75.1% of clients identified as female, 9.6% identified as male, and 16.8% identified as other or declined to state. When asked to report a monthly income, 62.8% made less than \$20,000 a year, and 24.2% made between \$20,000 and \$40,000 a year.</p>
