

AGREEMENT FOR SERVICES #398-S1610 (FENIX #758)
AMENDMENT I

This Amendment I to that Agreement for Services #398-S1610, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Renne, Sloan, Holtzman & Sakai, LLP, a Limited Partnership, duly qualified to conduct business in the State of California, whose principal place of business is 555 Capitol Mall, Suite 600, Sacramento, CA 95814; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide professional legal services on an “as requested” basis for the purpose of providing legal advice and representation in support of the County in employment and labor relation matters, in accordance with Agreement for Services #398-S1610, dated April 14, 2016, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase the total not to exceed amount by \$100,000.00 for a new total not to exceed amount of \$164,000.00 hereby amending **ARTICLE III – Compensation for Services**; and

WHEREAS, the parties hereto have mutually agreed to amend **ARTICLE XII – Notice to Parties** and **ARTICLE XXV – Administrator**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #398-S1610 shall be amended a first time as follows:

ARTICLE III is hereby amended to increase the total amount of the agreement by \$100,000.00 for a new total not to exceed amount of \$164,000.00, inclusive of all costs and expenses.
