Whereas, adoption is an important way to create families and provide much needed homes for children especially those in foster care; and,

Whereas, November has been designated as National Adoption Month; and,

Whereas, foster care and adoption services in El Dorado County are provided by Lilliput Children's Services, a non-profit agency, which recruits and trains local families with a goal of placing children who are currently in the foster care system into permanent homes and which assists families in all adoptions in the county; and,

Whereas, El Dorado County Adoption Day will feature a celebration that culminates in multiple adoption finalizations.




Passed by the Board of Supervisors of the County of El Dorado at a regular meeting of said Board, held the 7th day of November, 2006, by unanimous vote.
