



DRAINAGE EASEMENT

All that real property situate in the County of El Dorado, State of California, lying within the Southeast One-Quarter of Section 13, Township 9 North, Range 8 East, M.D.M. and being a portion of Lot 529, as shown on the plat of "West Valley Village Unit 5A", filed in the office of the County Recorder of El Dorado County in Book 'J' of Maps, Page 97, and being more particularly described as follows:

Beginning at a point on the Southerly line of said Lot 529, said point being the Westerly end of course number 20, as shown on said plat of "West Valley Village Unit 5A"; thence along the Southerly and Westerly line of said Lot 529 the following three (3) courses:


1. South 69°49'05" West, 43.67 feet; thence
2. Along the arc of a curve to the right, having a radius of 20.00 feet, the chord of which bears North 74°30'21" West, 23.33 feet; thence
3. North 38°49'47" West, 8.80 feet; thence

leaving said Westerly line, North 87°08'33" East, 73.81 feet to a point on the Southerly line of said Lot 529; thence along said Southerly line and the arc of a curve, concave to the Southeast, having a radius 323.00 feet, the chord of which bears South 70°15'52" West, 5.03 feet to the Point of Beginning, containing 652 square feet, more or less.

The Basis of Bearings for this description is identical with said plat of "West Valley Village Unit 5A".

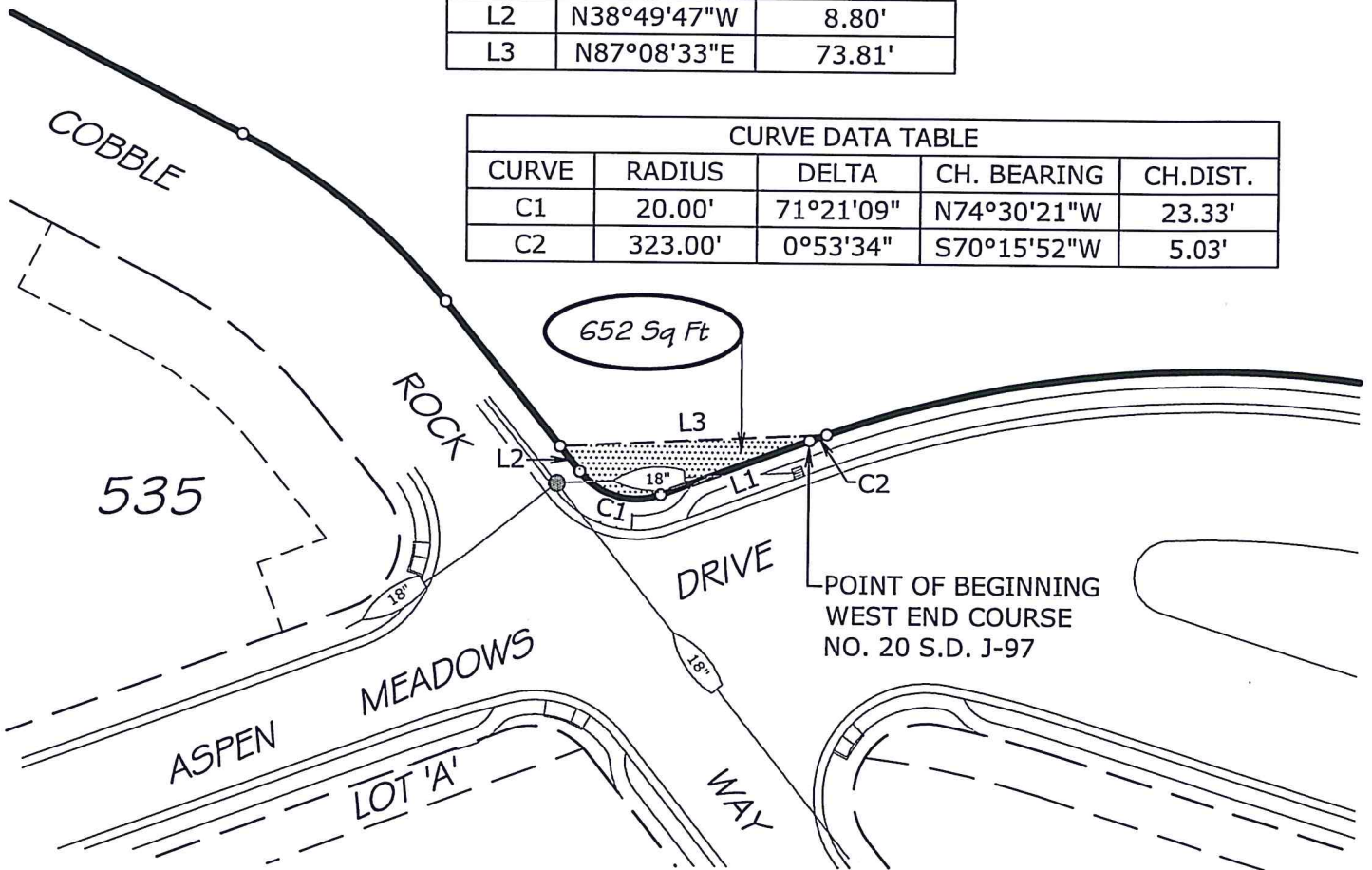
