

To Whom It May Concern:

I am writing to express my concerns and opposition to the proposed Bass Lake Family Apartments in Rescue, CA.

I've been looking into the validity of SB330 as it relates to this project and found the below website that was confirmed by a reply to an email I sent to the Housing and Community Development (HCD) Compliance Review office (see attached photo). In the verbage for SB330, it states that the law applies to "affected cities" as defined and identified by the Housing Crisis Act (HCA). If you find the proposed development on the HCD map, you will see that it is in a grayed out area and clearly states that the area is "Not Affected".

If SB330 only applies to areas that California deems "Affected" and HCD's own website clearly states that the proposed area for the development is "Not Affected", I think SB330 needs to be reviewed as to whether it can be used to push this project through.

In addition to questions about SB330's validity in relation to this project, there are more concerns:

- The proposed development will create water runoff issues and may increase the risk of flooding. I live in a house on Travois Circle that borders a creek where the water already gets very high during the rainy season. The lack of acknowledgement of drainage concerns and how the project would affect these drainage pathways is troubling.
- This development will negatively affect traffic congestion. With 170 allotted parking spots, at least 170 more cars will be on the roads in the area in addition to the increase of cars that will be parked on the street. Not only will this influx of cars be detrimental to our small community, but it creates traffic flow and student safety concerns with Green Valley Elementary School across the street from the proposed development.
- The Rescue Union School District is already exceeding capacity and the large number of new tenants in this development will add to the already impacted schools.

Thank you for your careful review of the many concerns related to the Bass Lake Family Apartments and for looking into the validity of SB330 and how it relates to this project.
