



**RESOLUTION NO. 010-2011**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**Transferring Type II Paratransit Buses to Tahoe Transportation District for Continued  
Transit Services to the Unincorporated Area of the County**

**WHEREAS**, County owns two 2009 Starcraft Allstar Type II paratransit buses that were utilized in transit services operations commonly known as “BlueGo” within the unincorporated area of the County in the South Lake Tahoe region until late July, 2010;

**WHEREAS**, on July 28, 2010 County withdrew from the Participation Agreement To Implement A Coordinated Transit System At South Lake Tahoe (“Participation Agreement”), and notified the Tahoe Transportation District (“TTD”) of its desire to identify an effective arrangement with TTD to return County’s paratransit buses to service for County’s constituents in the unincorporated area of the South Lake Tahoe region;

**WHEREAS**, on November 1, 2010 TTD commenced serving transit services within the South Lake Tahoe region inclusive of the unincorporated area of the County, pursuant to TTD’s authority under Article IX of the Tahoe Regional Planning Compact, and TTD is willing to accept the transfer from County of the two Type II paratransit buses to serve the constituents of County within the unincorporated area of the South Lake Tahoe region;

**WHEREAS**, TTD and County were co-sponsors under the Public Transportation Modernization, Improvement, and Service Enhancement Account (“PTMISEA”), a Proposition 1B program, for the purchase of the County’s Type II paratransit buses and the State of California has consented to this bus transfer to TTD as a co-sponsor so long as no funds are transferred as part of this exchange and that the TTD assumes any remaining PTMISEA reporting requirements, if any;

**NOW, THEREFORE, BE IT RESOLVED** that the County of El Dorado Board of Supervisors hereby transfers the hereinafter described buses to TTD for transit service use to the constituents of the County in the unincorporated area of the South Lake Tahoe region to meet the transit needs of the County in that region, and on condition that TTD assumes all future PTMISEA reporting requirements, and on condition that if the buses are permanently removed from service before the end of their useful life, they will revert back to the County and TTD will take all necessary and appropriate steps to transfer title.
