

## **Dewberry Engineers Inc.**

### **FIRST AMENDMENT TO AGREEMENT FOR SERVICES #7825**

**THIS FIRST AMENDMENT** to that Agreement for Services #7825 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "COUNTY"), and Dewberry Engineers Inc., a New York corporation duly qualified to conduct business in the State of California, whose principal place of business is 8401 Arlington Boulevard, Suite 1, Fairfax, Virginia 22031, and whose local address is 11060 White Rock Road, Suite 200, Rancho Cordova, California 95670 (hereinafter referred to as "CONSULTANT").

#### **RECITALS**

**WHEREAS**, CONSULTANT has been engaged by COUNTY to assist its Department of Transportation with as-needed construction support services for various COUNTY projects, pursuant to Agreement for Services #7825, dated September 26, 2023, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$1,000,000, amending **ARTICLE V, Allowable Costs and Payments**;

**WHEREAS**, the parties hereto desire to add a new Article to include updated contract provisions, adding **Exhibit F, "Iran Contracting Act Verification Form"**;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, COUNTY and CONSULTANT mutually agree to amend the terms of the Agreement in this First Amendment to Agreement for Services #7825 on the following terms and conditions:

- I. **ARTICLE V, Allowable Costs and Payments, Section P**, of the Agreement is amended in its entirety to read as follow:
  - P. The total amount payable by COUNTY for all Task Orders or Work Orders, including Task Order and Work Order amendments, and all costs, taxes, or expenses resulting from this Agreement shall not exceed \$1,475,000, as amended. It is understood and agreed that there is no guarantee, either expressed or implied that this dollar amount will be authorized under this Agreement through Task Orders or Work Orders.

II. **The following Article of the Agreement is added to read as follows:**

**ARTICLE LXV**

**Iran Contracting Act Certification:** As required by Public Contract Code section 2204, for Agreements that are over \$1,000,000, CONSULTANT certifies its status regarding the Iran Contracting Act of 2010 and has duly executed Exhibit F, marked "Iran Contracting Act Verification Form," incorporated herein and made by reference a part hereof.

Except as herein amended, all other parts and sections of Agreement for Services #7825 shall remain unchanged and in full force and effect.

**IRAN CONTRACTING ACT VERIFICATION FORM**

**(Public Contract Code sections 2202-2208)**

Prior to bidding on, submitting a proposal or executing a contract or renewal for a State of California contract for goods or services of \$1,000,000 or more, a vendor must either: a) certify it is **not** on the current list of persons engaged in investment activities in Iran created by the California Department of General Services ("DGS") pursuant to Public Contract Code section 2203(b) and is not a financial institution extending twenty million dollars (\$20,000,000) or more in credit to another person, for 45 days or more, if that other person will use the credit to provide goods or services in the energy sector in Iran and is identified on the current list of persons engaged in investment activities in Iran created by DGS; or b) demonstrate it has been exempted from the certification requirement for that solicitation or contract pursuant to Public Contract Code section 2203(c) or (d). Please note: California law establishes penalties for providing false certifications, including civil penalties equal to the greater of \$250,000 or twice the amount of the contract for which the false certification was made; contract termination; and three-year ineligibility to bid on contracts. (Public Contract Code section 2205.)
