

DESCRIPTION OF THE PROJECT The work to be done is shown on the Plans, and generally consists of, but is not limited to the following: construct fills and perform cold planning, paving, striping and signage work required to widen Latrobe Road within the limits of the Plans. Modify existing traffic signals at the intersection of Latrobe Road and White Rock Road, Latrobe Road and Town Center Boulevard, and Latrobe Road and the eastbound Hwy 50 off and on ramps. Construct concrete curb and gutter. Provide temporary and permanent erosion control. Modify existing and construct new drainage facilities.		
LOCATION OF PROJECT: This project is located on Latrobe Road from south of Highway 50 to south of the intersection of White Rock Road in El Dorado County.		
PORTIONS OF THE PROJECT TO WHICH THIS NOTICE APPLIES: All work specified in the Contract.

These items shall be completed by the Contractor within 60 Days of Substantial Completion; otherwise the Contractor does hereby waive any and all claims to all monies withheld by the Owner under the Contract to cover the value of all such uncompleted or uncorrected items.
