BH DIRECTOR & DEPUTY DIRECTOR UPDATES
(Nicole Ebrahimi-Nuyken)

- The BH Division submitted a PATH Justice Involved (JI) Readiness Assessment and Implementation Plan to DHCS. The Division will begin implementation activities once DHCS has provided the approval.
- Proposition 1 was passed by the voters in the March election. The transformation from a Mental Health Services Act funded behavioral health system of care to a Behavioral Health Services Act (BHSA) funded system of care will begin once further guidance has been received from the State. El Dorado County will utilize the ability to finish the current MHSA three-year-plan which ends on 6/30/26.

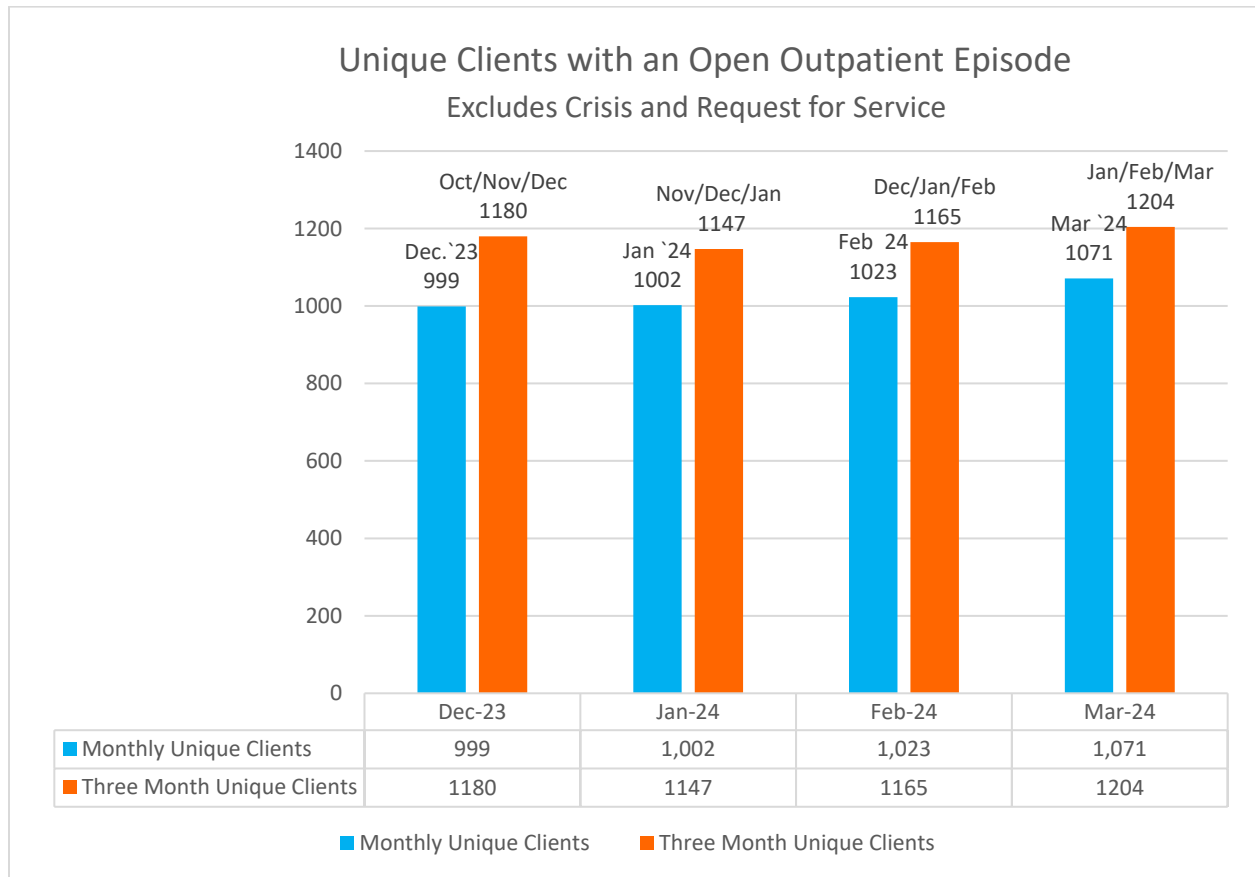

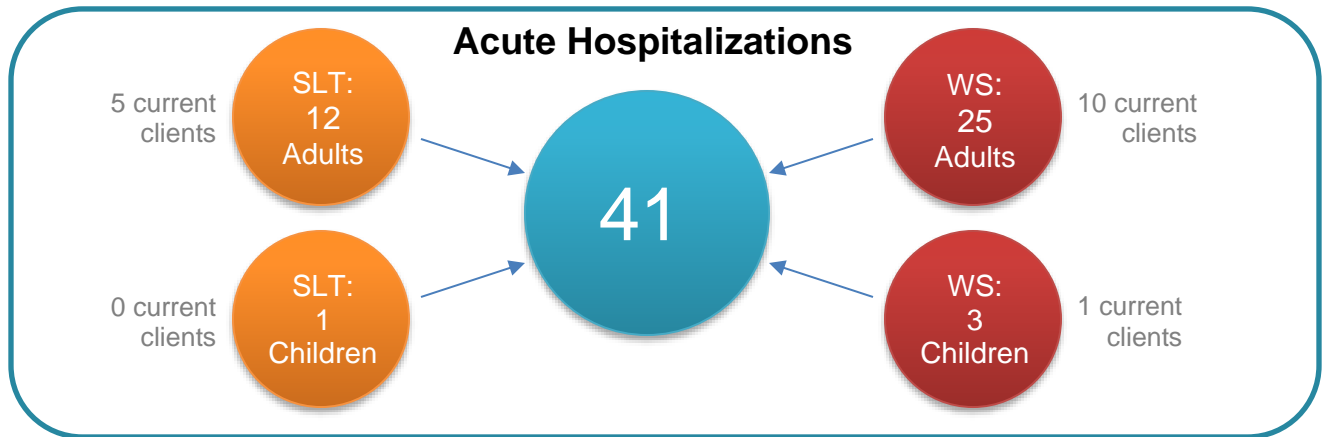

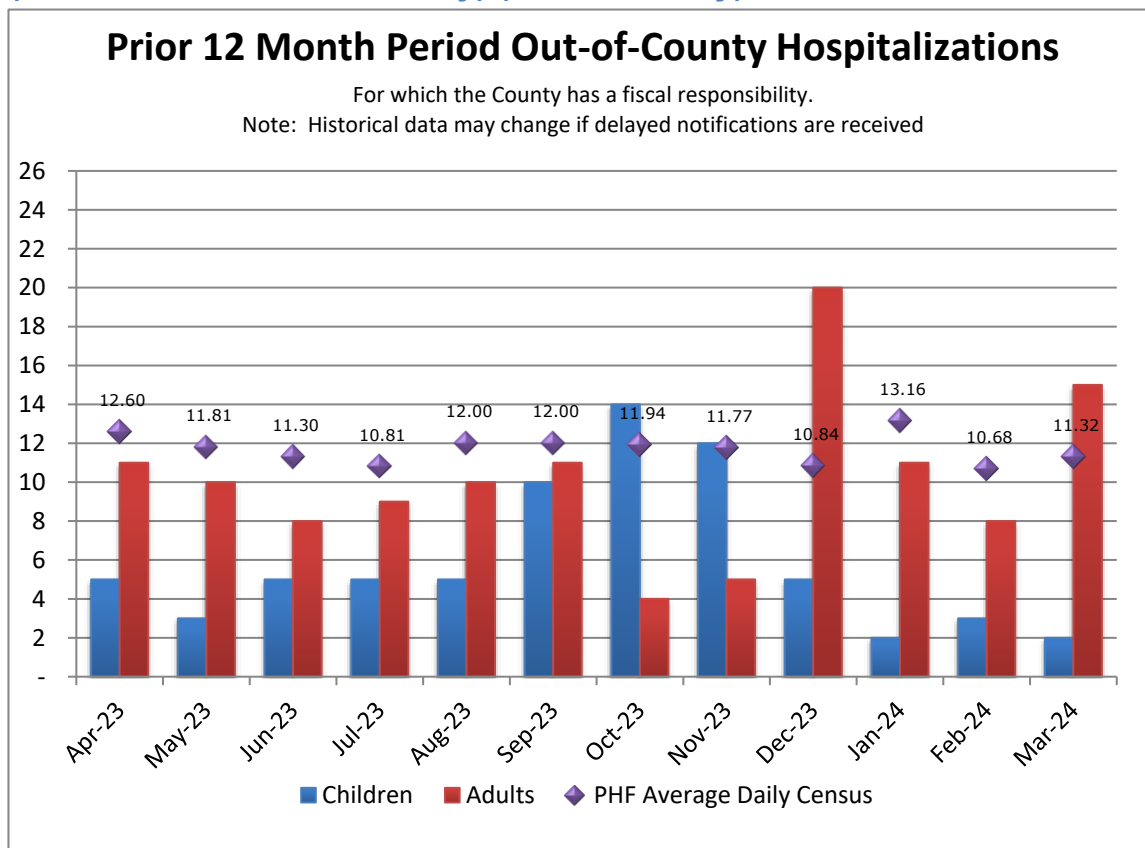

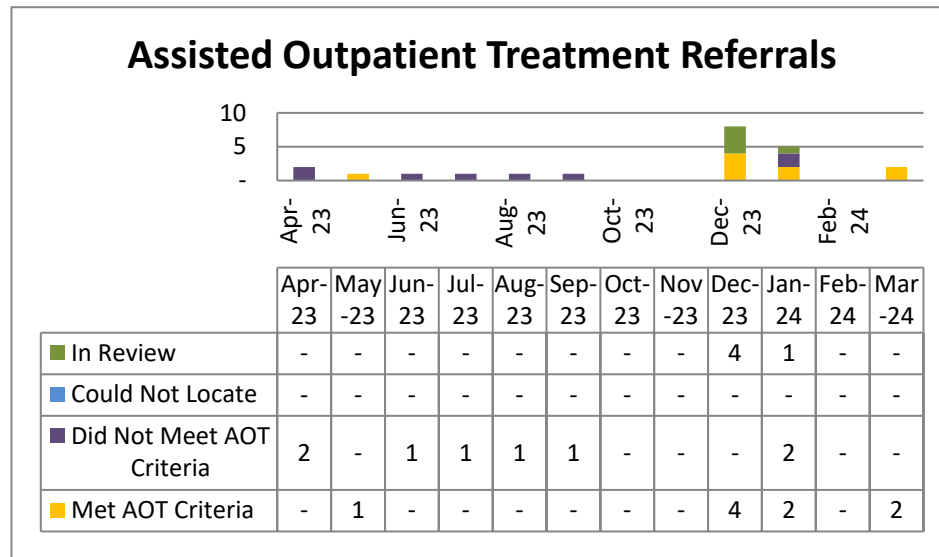
Psychiatric Emergency Services (PES) and Crisis Intervention Teams (CIT) (Scott Fisher and Karen Torry Greene)

QUALITY ASSURANCE & PATIENT RIGHTS

Quality Improvement / Utilization Review (Justine Collinsworth)

- The QM team is working with the MHSA team on developing an onboarding program for new hires to streamline their learning.
- The QM Team is focusing on utilizing the DHCS Transition of Care tool in order to have a warm handoff when transitioning consumers to a different level of care.
- The QM team continue to work in tandem with the IT and Fiscal teams on Interoperability with other mental health providers.
- DHCS sent notification that the 2024 Beneficiary Handbook was found to be in compliance with set standards.
- The QM team attended the annual CalQIC conference which brings together colleagues from other counties, DHCS leaders, and county supports like CBHDA and CalMHSA. There were robust discussions about new programming coming rolling out, such as: Path JI, Mobile Crisis, BH Connect, BHSA, and SB 43.

EDCBH has implemented a process to facilitate a due process hearing no later than 7 days from the initial detainment. A Certification Review Hearing is to be held at the ED (MMC/Barton), if a client continues to meet criteria for a 5150, and has been placed on a second hold, until transfer and placement arrangements to a LPS designated facility are completed or the hold is lifted.

PROGRAM ACTIVITY UPDATES

SUBSTANCE USE DISORDER SERVICES (Salina Drennan)

- In March, SUDS staff participated in a two-day Public Safety Realignment Strategy Workshop hosted by the El Dorado Community Corrections Partnership (CCP) that focused on identifying local opportunities and resources to address needs of criminal justice clients and prioritizing community strategies to make a positive impact. SUDS staff had the opportunity to participate along with other community partners to develop recommendations for future funding of local CCP programming.
- SUDS Prevention staff and students from Union Mine High School and Oak Ridge High School attended an anti-tobacco advocacy day called Youth Quest at the State Capitol this month. Students received training on educating decisionmakers about prevention topics and prepared talking points about how the commercial tobacco industry has negatively impacted youth in their communities. EDC students partnered with Placer County youth and prepared statements to share with staff from Assemblymember Patterson's office. The students met with Assemblymember Patterson's staff for about 30 minutes and their concerns about tobacco and vaping were very well received. ADULT OUTPATIENT SERVICES

(Jody Kwachak-Hall (SLT); Doris Jones (WS))

Tahoe:

- Adult Outpatient Clinicians and Mental Health Workers actively work with clients to provided MH services in the office, in clients' homes, by telephone, and by

telehealth. The Clinicians and Mental Health Workers provide services in community settings.

- SLT has 4 F/T & 1 extra-help Clinicians, and 5 F/T & 1 P/T Mental Health Workers providing services to 213 clients.

West Slope:

- Individualized services are provided to adults, age 18 years and older, who meet criteria for Specialty Mental Health Services by a multidisciplinary team of Psychiatrists, Nurses, Psychiatric Technicians, Mental Health Clinicians, and Mental Health Workers/Aides. Services include assessments, medication evaluations, clinical psycho-social and co-occurring assessments, individual therapy, group therapy, and rehabilitative and case management services and supports. Services are delivered in the Clinic, in clients' residences, in the community or via telehealth. Western slope outpatient program is currently being covered by a Program Coordinator, one full-time Clinician and one half-time Clinician due to multiple position vacancies.

Wellness Center Activities:

Tahoe:

- Wellness is open four days a week providing groups and activities to enhance Clients' lives (games, snacks, outings, art, independent living skills, symptom management, and skills educational groups, and more).

- The WSOP Wellness Center is open four days per week: Monday, Tuesday, Thursday, Friday from 1pm – 4pm. Closed Wednesdays, holidays, and weekends. The Wellness Center is a safe, welcoming space to partake in a meal, socialize, participate in a variety of groups, activities, and outings that emphasis,

independence, self-sufficiency, healthy living, healthy relationships, self-improvement and to share, learn, and to secure support, resources, education, and information.

There have been several WS Wellness Center participants who have begun to volunteer regularly and consistently in the Wellness Center in various roles such as thoughtfully engaging participants in activities to encourage socialization, decorating for the seasons and kitchen clean-up activities, stating that they want to “give back” because they have benefitted from attending and have received so much from their participation at the Wellness Center.

ICM Activities:

SLT: 12 clients participated in the seasonal start of the gardening group by learning about and preparing starter plants to be transplanted and grown in the Wellness Garden. 8 Clients engaged in a support group in preparation of completing housing applications for the new Sugar Pine apartments in SLT. 10 clients engaged in the cooking group, making a curry soup that was enjoyed by all. Action and fitness groups included Friends Fitness Hiking, Qi Gong Yoga, and Pickleball. Closed groups included DBT skills, yoga, and Wellness action-planning groups.

CHILDREN'S SERVICES (Justine Collinsworth):

Changes in billing and processes have created payment delays for our contractors. EDC HHSA is working on developing a more efficient invoice approval and payment process that meets everyone's needs.
