**NOTICE OF PUBLIC HEARING**

**Subject: Intention of Vacation; Roadways within the Green Springs Ranch Units 1, 2 and 3 Subdivisions**

Pursuant to Resolution No. 303-2002, the County of El Dorado Board of Supervisors will be holding a public hearing to determine whether or not Roadways within the Green Springs Ranch Units Nos. 1, 2 and 3 Subdivision, as described in Exhibit "A", and depicted in Exhibit "B", ~~attached hereto, shall cease to be public thoroughfares.~~ The public hearing will be held on January 28, 2003 at 9:00 a.m., or as soon as possible thereafter, at the Board of Supervisors Chambers, 330 Fair Lane, Placerville, CA.

Any interested members of the public are invited to attend said hearing and provide testimony either in support of or opposition to the proposed vacation of these public roadways. If the Board of Supervisors determines that it is in the public's best interest to proceed with the general vacation, said roads will cease to be public thoroughfares.

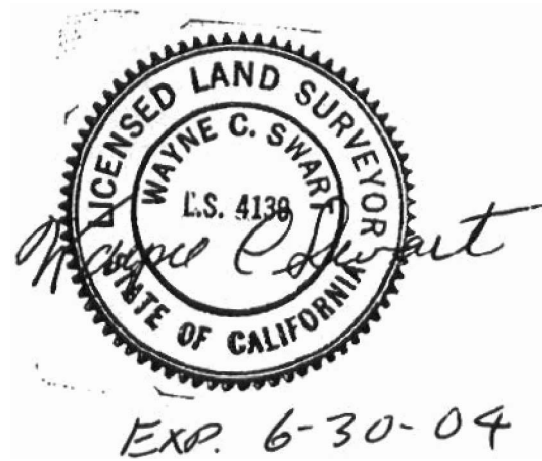

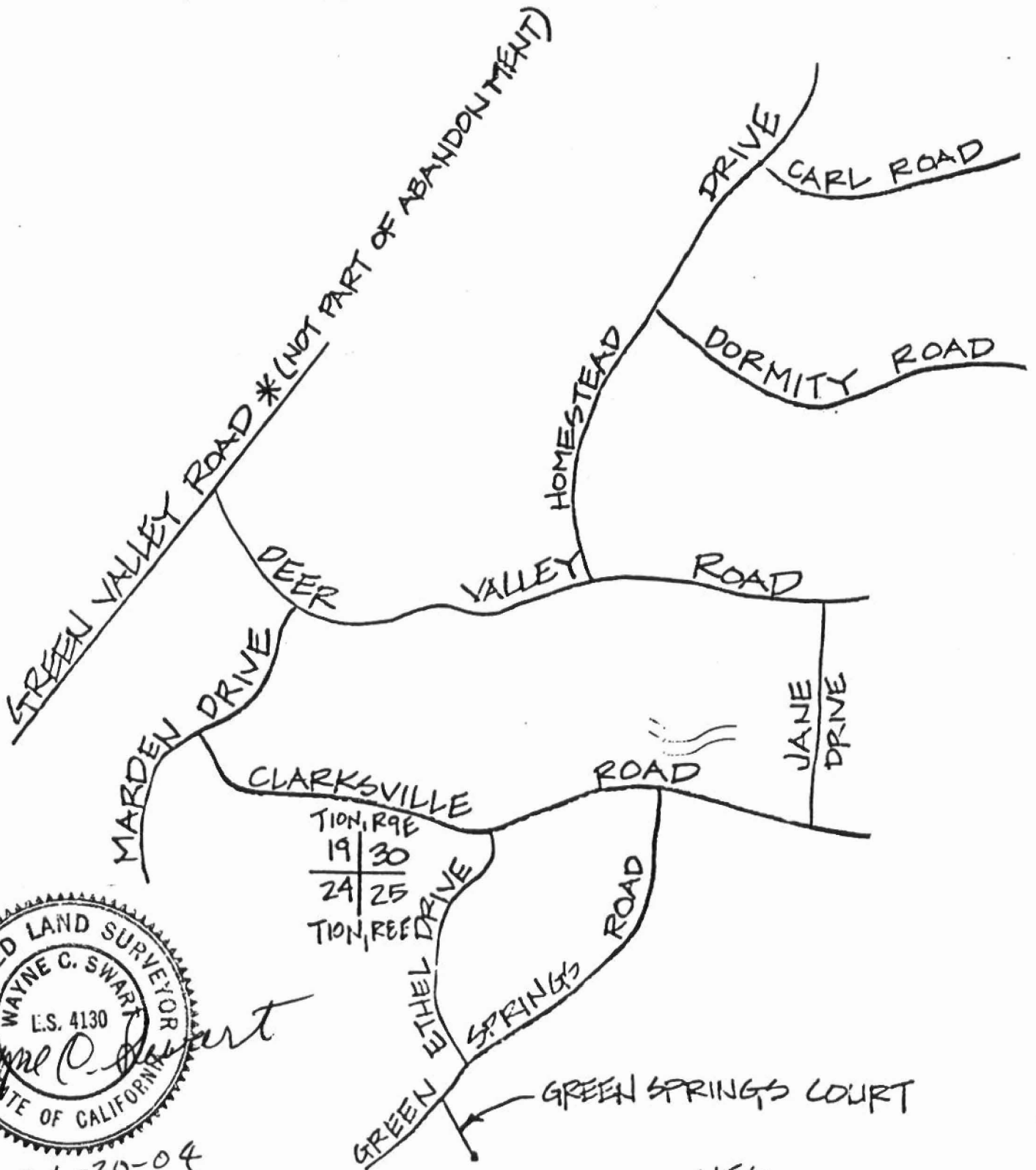

## ROADS IN GREENSPRINGS RANCH UNITS 1, 2 & 3



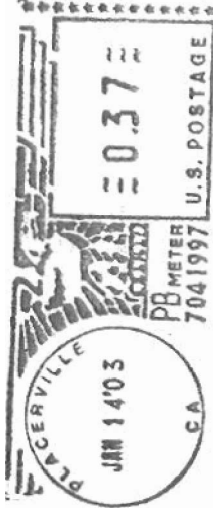
