AGREEMENT FOR SERVICES #4464 AMENDMENT I

This Amendment I to that Agreement for Services #4464, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Green Valley Mortuary LTD, a limited partnership, duly qualified to conduct business in the State of California, whose principal place of business is 3004 Alexandrite Drive, Rescue, CA 95672; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to assist the Sheriff's Office in the removal and transportation of decedents within the boundaries of El Dorado County, in accordance with Agreement for Services #4464, dated January 7, 2020, incorporated herein and made by reference a part hereof; and

WHEREAS, ARTICLE III Compensation for Services shall be amended by deleting the third paragraph in its entirety and replacing it with a new sentence; and

WHEREAS, ARTICLE XIII Notice to Parties shall be updated by replacing it in its entirety; and

WHEREAS, ARTICLE XXVI Contract Administrator; shall be updated by replacing it in its entirety.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #4464 shall be amended a first time as follows:

1. The third paragraph of **ARTICLE III, Compensation for Services**, of the Agreement is amended in its entirety to read as follows:

ARTICLE III

Compensation for Services:

Total amount of this Agreement for Services shall not exceed \$550,000.

2. **ARTICLE XIII, Notice to Parties**, of the Agreement is amended in its entirety to read as follows:

4. Except as herein amended, all other parts and sections of that Agreement #4464 shall remain unchanged and in full force and effect.
