OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RESOLUTION AUTHORIZING IMPLEMENTATION OF BLUEGO SERVICE AND FARE MODIFICATIONS EFFECTIVE NOVEMBER 23, 2008

WHEREAS, The County of El Dorado ("County") has operated a demand responsive transit system called BlueGO OnCall as part of the South Tahoe Area Transit Authority ("STATA") since its inception in 1991; and

WHEREAS, STATA was created by a Participation Agreement consisting of City, County, Douglas County, Tahoe Transportation District, Tahoe Regional Planning Agency ("TRPA"), Heavenly Mountain Resort, Harrah's Lake Tahoe, Harveys Casino Resort, Horizon Casino Resort, The Ridge Resorts and MontBleu Resort Casino and Spa for the purposes of managing, operating and maintaining a public transit service that is coordinated on the south shore under the brand name ("BlueGO"); and

WHEREAS, the County in conjunction with STATA has conducted public outreach and received support for the implementation of a fare and service modification to the BlueGO fixed route and demand responsive system operated for the residents and visitors of the south shore; and

WHEREAS, the County will benefit with enhanced public transit services for its residents and visitors with the proposed fare and service modifications; and

WHEREAS, STATA plans to implement the proposed fare and service modifications effective Sunday, November 23, 2008 or later as defined in Attachment A to the resolution, which includes the proposed fares, route maps and a description of the proposed service changes. This shall Attachment shall be incorporated into the Area Transit Management, Inc South Lake Tahoe Services Agreement For Services # AGMT 08-1691 as Attachment A; and

WHEREAS, The Participation Agreement to Implement a Coordinated Transit System on the South Shore, the requirements of the Transportation Development Act (TDA) and the Tahoe Regional Planning Agency's Regional Plan and Regional Transportation Plan supports this effort of implementing this MOU.

NOW, THEREFORE, BE IT RESOLVED, that the El Dorado County Board of Supervisors hereby:

1. Authorizes the South Tahoe Area Transit Authority to Implement BlueGO Service and Fare Modifications Effective Sunday, November 23, 2008 as defined in Attachment A.


Children under 5 can ride free.

Service Animals are free with a person with disabilities riding the bus.


Transfers would be eliminated.

BLUEGO EXISTING BUS ROUTES/SERVICE AREAS






