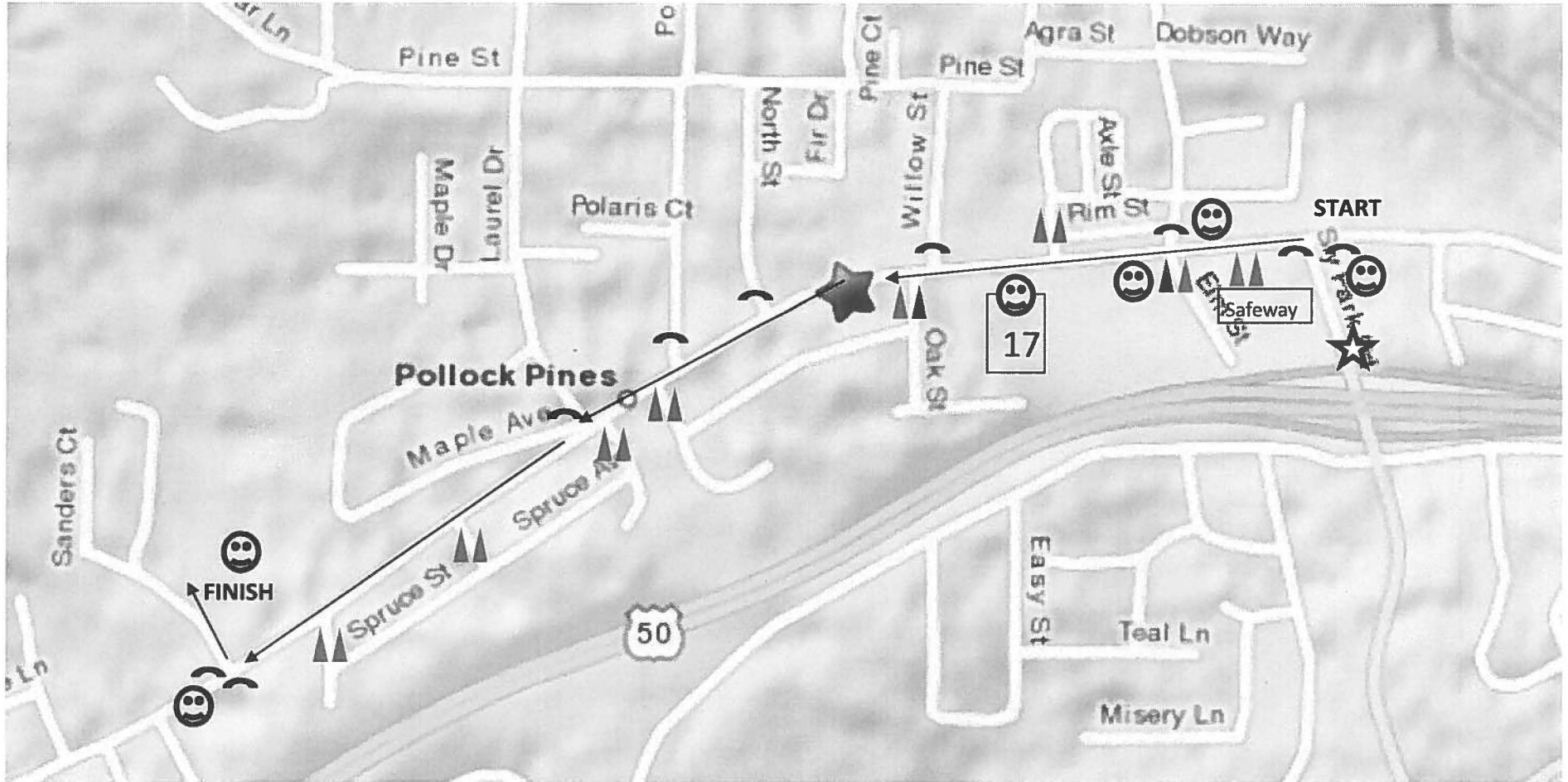

(Vehicles will be turned around/not allowed to wait)

Forebay Road: Forebay to Blair Road to Pony Express Trail

Sly Park Road: Cars will be turned around, they can then use Hwy 50 or Ridge-way to access the other side of the road closure.
